Dream Camp will be held in Madison, WI from October 15,16 and 17, 2024 and are subject to change in the Administrator's sole discretion. At least the top 100 finalists Submissions Materials, if not all, will be evaluated by a judging panel of representatives of the Administrator. The judging panel will make its decision based on the following criteria:

•Inspiration (20%): Is the dream inspirational in nature and a positive representation of the American Dream?

- Feasibility (20%): Can the proposed dream realistically be accomplished with available resources in 2024?
- •Impact (20%): Will it have a meaningful impact on the Entrant, someone close to them (friends or family) or another party?
- •What challenges are identified? (10%): Are the challenges identified and can they be addressed through Dream Camp?
- •What would help most in achieving this dream (10%): Is there a clear understanding of what would help to achieve the dream including clear items identified that we can help with through Dream Camp and the ongoing support.
- Supporting files (10%): Is there a supporting video or audio file included and does strongly supports this applicant's application?
- •Overall (10%): Does the contestant make a good candidate for Dream Camp and align with the brand? If there is a tie, American Family Insurance reserves the right to look at the collective whole of the top 12 finalists to make final selections for the final 6 selected winners upon their discretion. Winner will be notified on or about August 30, 2024.
