

DREAM GAME DAY SWEEPSTAKES (“SWEEPSTAKES”)

OFFICIAL RULES

Limit one (1) entry per person throughout the Entry Period. By successfully transmitting a completed online entry form as directed, you will be entered in the Sweepstakes. All information submitted online by entrants is subject to, and will be treated in a manner consistent with, Sponsor’s Privacy Policy located at <https://www.amfam.com/privacy-security>. Entrants must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete and/or inaccurate entries are void. All online entries must include a valid email address for the entrant.

RANDOM DRAWING: The potential winner of the Sweepstakes will be selected by random drawing on or about July 11, 2026 (“**Drawing Date**”), from among all eligible entries received. Subject to verification of eligibility and compliance with the terms of these Official Rules, the potential winner will be declared the official winner of the
