The purpose of this template is to provide CCOs with a guide on how to identify key stakeholders impacted by the changes brought by the newly designed roles.

This document also provides examples on how various stakeholders may be engaged throughout the Job Redesign journey.



# Objectives

- To obtain an overview of the stakeholders impacted by the new roles, the specific impacts to them, and the different stakeholder management that may be required
- To identify key messages and methods of deliver for each stakeholder group, depending on the outcomes from the Influence x Impact 2x2 Matrix


# Step 1. List potential stakeholders for mapping

Guiding Questions	List of stakeholders for mapping
<ul style="list-style-type: none"><li>• Who makes decisions for this project / more broadly in the CCO?</li><li>• Who will affect or contribute to the success of the project?</li><li>• Who will the new roles directly or indirectly impact?</li><li>• What are some of the adjacent roles that will work with the new roles?</li></ul>	 <p><i>Sample list:</i></p> <ul style="list-style-type: none"><li>• CEO</li><li>• Project Sponsor</li><li>• Physiotherapists</li><li>• DON</li><li>• Nurse Manager</li><li>• S/CCAs</li><li>• Cluster Nurse</li><li>• Head of CBS / Day Care</li><li>• Cluster Lead</li></ul>


# Step 2. Stakeholder Mapping Template
