

Our Hong Kong office is involved in pro bono projects supporting access to justice in a number of areas, including helping displaced people and migrant workers. This work reflects the culture of our firm and our responsibility to help build a fair and equitable society. We also encourage collaboration between a range of diverse stakeholders to bring new and original ways of thinking to the legal challenges faced by those seeking access to justice and to address a broad range of social needs.

People at A&O Shearman come from all kinds of backgrounds and we are determined to maintain an environment where everyone feels supported.

We conducted unprecedented research, which identified over 100 occurrences across 21 areas of Hong Kong law and government policy of widespread and inconsistently applied instances of differential treatment according to

relationship status. The research report highlights that couples in same-sex relationships do not enjoy many of the same rights and benefits as people in opposite-sex relationships.

Our office is actively engaged with The Zubin Foundation (TZF), a local NGO involved in improving the lives of Hong Kong's marginalized ethnic minorities by providing them with opportunities and reducing their suffering. We partnered with TZF to launch The Institute of Racial Equality in Hong Kong, and we hosted a number of webinars to raise awareness of the challenges ethnic minorities face in Hong Kong, and how we and other businesses in Hong Kong can help.

Our office staff also contributes hundreds of volunteer hours to various mentoring programs and other volunteer activities, including for TZF, Crossroads Foundation, HandsOn Hong Kong and Box of Hope.

The Hong Kong Council of Social Service has recognized A&O Shearman as a Caring Company for over 20 years. We recruit from a wide variety of campuses and we are interested in graduates from a broad range of disciplines. This diversity of background and skills is vital for our business, as the role of a lawyer evolves and our clients' needs become ever more sophisticated. The path to qualification looks broadly like this:

Law degree/JD

A&O SHEARMAN EVENTS:

We usually organize events including recruitment talks, Open Days, and information sessions for junior law students and final year non-law students considering a career in law. These events currently take place in September/October in Hong Kong, November in the UK, and March/April in Australia.

VACATION SCHEME:

A four-week work placement with us in Hong Kong, in either June or July.

Studying for Juris Doctor?

The Vacation Scheme is for you too.

PCLL

A&O SHEARMAN TRAINING CONTRACT APPLICATION:

We primarily select our trainees from the Vacation Scheme and offer them a Training Contract two years in advance. We will, however, consider direct Training Contract applications on a case-by-case basis throughout the year, if vacancies are available.

POSTGRADUATE CERTIFICATE IN LAWS (PCLL):

You must complete the PCLL course at one of the university providers in Hong Kong – The Chinese University of Hong Kong, The City University of Hong Kong or The University of Hong Kong. The PCLL is a one-year full-time course which runs from September to June. This must be completed prior to starting your Training Contract.

If your law degree or JD is from an overseas university, you will need to complete PCLL conversion exams prior to starting the PCLL course.

TWO-YEAR A&O SHEARMAN TRAINING CONTRACT:

Divided into structured training placements (called 'seats'), usually including a six-month secondment to our overseas office.

Qualify as a solicitor

NON-LAW STUDENT REQUIREMENTS

Non-law students are required to attain a law degree or law compliance recognition qualification such as the Graduate Diploma in Law (GDL) in the UK, Common Professional Examination in Hong Kong or Juris Doctor in Hong Kong or Australia or a Bachelor of Laws (LLB) in Hong Kong, Australia or the UK (common law/commonwealth jurisdictions).

If you choose to do a GDL in the UK, you are welcome to apply for a Vacation Scheme in the final year of your undergraduate degree.



Applications are welcomed from penultimate and final year law students, or final year non-law students at university in Hong Kong, the United Kingdom, Australia, New Zealand and other common law jurisdictions. We are also looking for individuals who can demonstrate consistently strong academic performance, so we expect you to be heading for at least 2:1 or equivalent for your law degree or JD. To work in Hong Kong, you will also ideally possess

Chinese (written and spoken) language skills. Prior legal experience is not a requirement.

During the program you will gain real experience in our practice areas, working alongside our lawyers on real deals and cases. You will have the opportunity to sit in two practice groups for two weeks each. There will also be time to socialize with our lawyers, partners, other interns and the graduate team during your placement. This will help build your network and broaden your understanding of the firm.

Students who complete a Vacation Scheme with us will be considered for a training contract. The decision will be based on the feedback provided by our trainers, as well as the outcomes of the assessments conducted throughout the Vacation Scheme. We ultimately believe a Vacation Scheme is a two-way process and a chance for you to work out if A&O Shearman is the right firm for you. You will then be sent an email which will contain a link to complete an interactive assessment. The assessment will include verbal and numerical reasoning items and two short motivation questions to complete via video. The interactive assessment is untimed and should take around 45 minutes. The interactive assessment is designed to provide a realistic preview of what you may experience as a trainee at A&O Shearman as well as give us an insight into your motivations.
