End of Participant Enrollment

After careful consideration of numerous factors and evaluation of the risk-benefit tradeoff for patients, study leadership ended study accrual on Friday, March 1, 2024, at 11:59pm ET. At

that time, patient registration into the study portal closed, and this deadline applied to all race/ethnicity cohorts. Please read the full, official **Study Closure Memorandum**.

Site and Facility Closeout

ACR®, the study sponsor, will continue to help facilitate closeout activities for both dementia practices and imaging facilities. Please review the following important reminders regarding closeout:

- The New IDEAS Operations Team will contact you regarding outstanding data, individual timelines and additional closeout procedures.
- Dementia practice site principal investigators, or their designated staff, are responsible for submitting a termination report with the IRB after all study activities and data are complete. - As you review or reconcile payments received, please review the finance tab in the portal and reach out to newideas@acr.org with any further questions.
- Facilities will be responsible for completing all contract-related data transfers, including form submissions in the **New IDEAS Portal**, image uploads to **TRIAD** and coinsurance reimbursement requests.

Coinsurance Reimbursement Program Closure

PET imaging facilities have until June 1, 2025, to submit and reconcile any remaining coinsurance reimbursement forms in the study portal. The program closure date, which is more than one year from the last service date of the scan completed as part of the study, allows sufficient time for facilities to complete the billing and submission cycle.

- The study sponsor will pay for coinsurance amounts that Medicare beneficiaries participating in the study would otherwise owe for Medicare-reimbursable amyloid PET scans provided during the study, regardless of financial need.
- Coinsurance amounts associated with the amyloid PET scan (including technical, professional or global charges) and/or fixed copayments not covered by patient supplemental insurance are reimbursed under this program.
- Unmet beneficiary deductibles and coinsurance or copayments associated with dementia expert visits are not reimbursed under this program.
- If your facility is currently experiencing issues with Medicare reimbursement or prior authorization requests for amyloid PET scans conducted through New IDEAS, please contact newideas@acr.org with the details.

Biosample Collection Program Termination

Patients participating in New IDEAS consented to providing a saliva sample and may have consented to providing a blood sample. Final biosample kits are expected to ship to participants by the end of 2024.

- Patients should be instructed to complete these study activities as outlined on the study informed consent form.

- The final date to request replacement kits is Dec. 31, 2024. Please contact newideas@acr.org if your patient needs a replacement kit or has not received their original kit shipment.
- Participants will have until June 1, 2025, to return their biosamples. Samples received after that date will be destroyed and not included in the biorepository and no payment will be made.
- As a reminder, your practice will not submit a termination report to the IRB until you've shipped all patients their biosample kits, including any replacement kits.

Study Wrap Up — Updates for the Next Phase

New IDEAS Data Analyses

In 2024, the New IDEAS Study Team devised two working groups to collaboratively work on data analyses and publications. The Primary Analysis working group focuses on key findings associated with the study's aims and objectives. The Social Determinants of Health working group uses data from New IDEAS to estimate associations between social determinants of health with Amyloid PET positivity status as well as changes in management for a cohort of Medicare beneficiaries with cognitive impairment. All study results will be shared broadly with sites and communities, and published on the [Recent Study Updates](#) webpage.

Learning From Our Partners

The New IDEAS Recruitment and Community Engagement Teams are actively working to learn from the New IDEAS Study partners to improve recruitment and community engagement strategies in future projects.

- **New IDEAS Recruitment Experience Interviews** — Vanderbilt University Medical Center will use a multi-methods approach to evaluate the New IDEAS Study site recruitment experience. Their approach includes a qualitative research plan that aims to explore overall views, facilitators, limitations and areas of improvement for recruiting into the New IDEAS Study. Semi-structured interviews will take place with participating sites through June 2025.
- **New IDEAS Focus Groups With Community Partners** — The University of North Carolina Chapel Community Engagement Specialist Team will conduct focus groups with New IDEAS Study Champions, Alzheimer's field offices and other partners to gather focused feedback about their experiences during the study process and supplement the knowledge gained through Alzheimer's community-engaged work.

IDEAS Study Program Data Requests

The IDEAS Study program, which includes the IDEAS Study and New IDEAS Study, is committed to providing academic and industry investigators the opportunity to access study data for purposes consistent with IDEAS Study program goals. This may include ancillary research studies, technology development and educational initiatives.

The New IDEAS Study Team developed numerous resources and programs to ensure that patients have the required information to complete study-related activities. Please share the following reminders with patients participating in New IDEAS:

- **Review the Blood Draw Information Sheet** — This resource answers frequently asked questions about the blood draw and helps patients feel more comfortable donating blood for memory loss research.
- **Consider optional in-home blood collection services** that patients may choose instead of going into a local Quest Lab.
- Request a replacement saliva or blood kit — Patients who need new saliva and/or blood kits should contact their memory care doctor. Practice staff are encouraged to email **newideas@acr.org** to request replacement kits no later than Dec. 31, 2024.
