

## Notice of change in share capital

Milan, 10<sup>th</sup> September 2021 – BFF Bank S.p.A. (“**BFF**” or the “**Bank**”), pursuant to article 85-bis of CONSOB Issuers’ Regulation n° 11971/1999 as subsequently amended, communicates the new composition of its share capital (fully subscribed and paid-in), following the partial execution of the share capital increase free of charge resolved by the Bank’s Shareholders’ Meeting on 2<sup>nd</sup> April 2020 (“**Share Capital Increase Free of Charge**”).

As a result of the execution of the Share Capital Increase Free of Charge, over the period between 12<sup>th</sup> August 2021 and 9<sup>th</sup> September 2021, BFF’s share capital increased for an amount equal to Euro 1,188.88, through the issuance of 1,544 new BFF ordinary shares, assigned to BFF Group’s employees in relation with the remuneration and incentive policies’ requirements, in the context of:

- (i) the *Management by Objective* incentive system;
- (ii) the “*Stock Option Plan of Banca Farmafactoring Banking Group*” originally approved by the Shareholders’ Meeting on 5<sup>th</sup> December 2016 and modified by the Shareholders’ Meeting on 28<sup>th</sup> March 2019 (“**Stock Option Plan 2016**”).

The certificate of the change in share capital was filed with the Companies’ Registration List of Milan, Monza Brianza and Lodi, on 10<sup>th</sup> September 2021.

With reference to the Stock Option Plan 2016, it should be further noted that, from the beginning of the exercise period (8<sup>th</sup> April 2019) until 9<sup>th</sup> September 2021, 1,235,904 shares (of which 842,829 newly issued) were assigned, against 5,191,392 options exercised on a cash-less basis and 401,638 options exercised with the ordinary method over the same period. The number of

options assigned and not exercised yet to date amounts to 2,740,150, of which 1,771,150 are vested and exercisable options.
