# ARMES FAMILY CANCER CARE CENTER UPDATE



If you've driven past the construction site at EasternWoods, you will see the project is rapidly progressing with expected completion around the end of September 2015. Here are some of the latest developments:

- Construction is approximately 50 percent completed in the new addition.
- Stud and drywall installation is proceeding from the east end of the building to the west.
- Healing garden formation has commenced. Sidewalk and courtyard concrete will be poured within the next two weeks followed by planting expected to be completed by the end of June. Extension of the existing irrigation system has been approved to assure the long term beauty of the garden.

- Interior renovation work will be completed in eight small phases so as not to interfere with ongoing patient services. Existing building renovations will occur concurrent with work on the new addition.
- Mid June work will commence on a new entrance to the building that will eliminate cold drafts entering the lobby during the winter months. The entrance will feature sliding glass doors and a heated vestibule.
- Findlay Machine & Tool will begin sculpting the healing tree in approximately two weeks and expect to have the project completed in August.
