If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> . Unless a <u>copay</u> , fee, or other percent is shown, the <u>coinsurance</u> percent of the <u>allowed amount</u> that you pay for most services is 30% <u>in-network</u> .
Are there services covered before you meet your deductible?	Yes. <u>Primary care</u> and <u>specialist</u> visits, certain <u>preventive</u> services, <u>in-network</u> imaging services, <u>prescription drugs</u> , <u>specialty drugs</u> , <u>emergency room care</u> , <u>urgent care</u> visits, mental health visits, and hospice services are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
