What is the overall deductible?	<u>In-network</u> and <u>out-of-network</u> combined: \$2,500/individual or \$5,000/family per calendar year	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> . Unless a <u>copay</u> , fee, or other percent is shown, the <u>coinsurance</u> percent of the <u>allowed amount</u> that you pay for most services is 0% ("no charge after <u>deductible</u> ") <u>in-network</u> and 50% <u>out-of-network</u> .
Are there services covered before you meet your deductible?	Yes. <u>In-network</u> : <u>primary care</u> and <u>specialist</u> visits, <u>urgent care</u> visits, mental health outpatient services, and routine eye exams are covered before you meet your <u>deductible</u> . <u>In-network</u> and <u>out-of-network</u> : <u>prescription drugs</u> , <u>emergency medical transportation</u> , and <u>hospice services</u> are covered before you meet your <u>deductible</u> . Does this plan provide Minimum Essential Coverage? Yes

Minimum Essential Coverage generally includes plans, health insurance available through the Marketplace or other individual market policies, Medicare, Medicaid, CHIP, TRICARE, and certain other coverage. If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.

Does this plan meet the Minimum Value Standards? Yes

If your plan doesn't meet the Minimum Value Standards, you may be eligible for a premium tax credit to help you pay for a plan through the Marketplace.
