INTRAOPERATIVE ASSESSMENT OF TISSUE PERFUSION

Description:

Indocyanine green (ICG) fluorescence angiography, also referred to as fluorescent angiography or Spy® angiography, involves intravenous injection ICG during surgery. The dye binds to proteins in the blood and emits light when stimulated by a low energy laser. Blood flow can be visualized through the operative tissue, therefore, determining perfusion and viability.

Fluorescence imaging systems include, *but are not limited to*:

- PINPOINT Endoscopic Fluorescence Imaging System
- SPY® Elite Fluorescence Imaging System
- SPY® Fluorescent Imaging System
- SPY® scope Intra-operative Imaging System

Criteria:

The following criterion applies to BCBSAZ local lines of business only. For all other lines of business, refer to *“Included Services” Pricing Guideline*.

- Intraoperative assessment of tissue perfusion by any technology, including but not limited to fluorescence angiography, fluorescent angiography, Spy angiography or Spy Elite or PINPOINT is considered included in the primary procedure, and therefore, is ***not eligible for separate reimbursement***.
