## **BOKF USE OF LIKENESS FOR ATTENDEES AGREEMENT**

**Waiver.** I hereby waive any inspection or approval of use. I also waive and release BOKF from any claims based upon invasion of privacy, right of publicity, defamation, false endorsement, trademark or copyright infringement or claim of visual or audio alteration or faulty mechanical reproduction.

**Release and Hold Harmless.** I, the Attendee, hereby irrevocably release, discharge, waive and agree to hold harmless BOKF NA and all of its affiliates, their respective successors and assigns and all of their respective agents, officers, servants, employees, representatives, contractors, shareholders and directors of and from any and all liability, claims, demands, causes of action, and damages due to injury to person that may be sustained by me pertaining to use of my Likeness.

**Binding Upon Heirs.** This Agreement for Use of Likeness, Release and Hold Harmless Agreement shall be binding upon the Attendee and each of the Attendee's distributees, heirs, next of kin, executors and administrators ("Heirs").

This Use of Likeness shall be subject to, and interpreted by and in accordance with, the laws (excluding conflict of law provisions) of the state in which I executed this Agreement. Generally, that state will be the State of Oklahoma, the principal place of business of BOKF.

- 2. That I have read the foregoing agreement for use of Likeness, release and hold harmless provisions, understand them, and sign this Release, Indemnity and Hold Harmless Agreement voluntarily;
- 3. That I am over 18 years of age and of sound mind;
- 4. I fully understand that I am giving up and waiving legal rights and those of my minor child(ren) as their parent/guardian and it is my intention to do so freely and without coercion or duress of any type.
- 5. That I am participating in this activity on my own free will and recognize that my attendance is voluntary.
