Session 2: Do Reasons Matter: Assessing Parental Reasons in Pediatric Decision-Making **Location: Connect A1**

Description:

This session explores the ethical complexities of parental decision-making in pediatric care, focusing on how clinicians assess the reasons parents give for their choices. It will examine the moral distress that can arise when clinicians disagree with those decisions and offer practical strategies for ethical engagement and resolution.

Objectives:

- Explore ethical frameworks for evaluating parental decision-making in pediatric care, with particular attention to how the quality and rationale of parental reasons can impact the child's best interests.
- Analyze sources of moral distress in clinicians arising from disagreements with parents' decisions.
- Apply case-based discussion to identify appropriate clinician responses when parental decisions appear ethically troubling, balancing respect for parental authority with professional obligations to the child.

Session 3: Caring for Victims of Child Maltreatment and Their Families **Location: Connect A3**

Caring for children when there are concerns of child maltreatment has its own unique set of challenges. These can include hostile parents, questions about who can visit, and even personal distress triggered by the situation. This presentation will explain what goes into making a diagnosis of child abuse. It will explain the care and work up they may require. It will also help the attendee develop a strategy for responding to questions from parents and investigators.

Session 5: Think Like a SANE Nurse: Forensic Care Principles for Every Pediatric Nurse **Location: Connect A3**

Description:

Sexual Assault Nurse Examiners (SANEs) play a critical role in bridging healthcare and the justice system, especially in pediatric settings where trauma, vulnerability, and complexity intersect. But the principles of forensic nursing don't belong solely to SANE-trained staff; they're essential for every pediatric nurse.

This session provides an overview of forensic nursing and the SANE program at Children's Wisconsin, highlighting how it was built, how it serves patients, and how it collaborates across disciplines. More importantly, it equips attendees with practical tools to "think like a forensic nurse" in any pediatric care setting. From preserving evidence to trauma-informed communication, attendees will learn the clinical, legal, and ethical considerations that can shape outcomes for children experiencing abuse.

Whether you work in the emergency department, inpatient units, outpatient clinics, or school-based settings, this presentation will help you recognize red flags, respond appropriately, and integrate forensic awareness into your everyday nursing practice. By learning to think like a forensic nurse, you can play a vital role in protecting vulnerable children, supporting trauma recovery, and contributing to a coordinated, compassionate response to abuse.

Objectives:

- Explain the role and scope of practice of a Sexual Assault Nurse Examiner (SANE), including the clinical and forensic responsibilities within a pediatric healthcare setting.
- Apply core forensic nursing principles, such as trauma-informed care, evidence preservation, and chain of custody, to routine pediatric nursing practice across various clinical environments.
- Identify appropriate strategies for recognizing signs of abuse, demonstrate proper initial responses to patient disclosures, and describe when and how to collaborate with SANE nurses and interdisciplinary partners.
