Driver Identification Mobile Application N/A \$1.50/driver

The mobile application communicates directly with the Azuga device in the vehicle to identify the driver without the driver needing to take any action other than to be logged on to the application. This solution enables customers to positively identify the mobile worker driving each vehicle through the deployment of a QR code which is affixed to the vehicle interior. Driver Identification Beacon Card \$15.00 \$1.50/driver

This solution enables customers to positively identify the mobile worker driving each vehicle through the deployment of a credit card sized plastic card. The card identifies the driver by communicating a driver-specific code to the Azuga device in the vehicle via Bluetooth.
