# Sesame Street Muppets Joined Researchers and Advocates on Capitol Hill to Discuss Early Results of Autism Initiative

On Tuesday, April 4, 2017, Sesame Street's newest neighbor, Julia, a Muppet who has autism, went to Capitol Hill to listen as researchers discussed preliminary findings from an impact study evaluating the Sesame Workshop initiative "Sesame Street and Autism: See Amazing in All Children." Acclaimed actress, author, and philanthropist Holly Robinson Peete, founder of the HollyRod Foundation, moderated the panel discussion.

The Sesame Workshop initiative, launched in 2015, aims to reduce stigma and build understanding about autism spectrum disorders. In 2016, Sesame Workshop contracted Bruno Anthony, PhD, deputy director of the Georgetown Center for Child and Human Development, and his wife and research collaborator Laura Anthony, PhD, Associate Director of the Center for Autism Spectrum Disorders at Children's National Health System, to conduct real-world testing of the initiative's online materials. These resources include videos, daily routine cards, and an eBook, written by Leslie Kimmelman, titled "We're Amazing, 1,2,3!", and can be accessed for free at www.sesamestreet.org/autism. Preliminary findings from the study were presented and discussed during an expert panel session at the U.S. Capitol Visitor Center. The Advocates in Disability Award (ADA) is a national awards program that seeks applications from young adults with a disability, between the ages of 14 and 26, who are dedicated to positively affecting the lives of individuals with disabilities and their families. The program also supports an innovative project developed by the recipient to serve and empower individuals with disabilities. The ADA is a joint program of The HSC Foundation and the Mitsubishi Electric America Foundation. The selected recipient is awarded \$3,000 in recognition of his or her disability advocacy and will receive up to an additional \$7,000 in funding for a project to benefit the disability community. Applicants must be a citizen or permanent resident of the United States at the time of application submission and recipient selection.
