

PokerStars Exclusively on FanDuel EPT Package Giveaway Sweepstakes at Live! Casino & Hotel Maryland

Official Rules

Void where prohibited by law and outside the United States. Subject to all federal, state, and local laws, regulations, and ordinances.

MUST BE 21 YEARS OF AGE OR OLDER AT TIME OF ENTRY.

ALL DISPUTES WILL BE RESOLVED SOLELY BY BINDING ARBITRATION AND PARTICIPANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.

1. Timeframe

The PokerStars Exclusively on FanDuel European Poker Tour (EPT) Package at Live! Casino & Hotel Maryland commences at 11:15AM Eastern Time ("ET") on Wednesday, August 26, 2026 and ends at the conclusion of the Maryland State Poker Championship Event #16 on Monday, September 7, 2026.

2. Sponsor and Affiliate

TSG Interactive US Services Limited, 251 Little Falls Dr, New Castle, Wilmington, Delaware, 19808 ("Sponsor"). PPE Casino Resorts Maryland, LLC, 7002 Arundel Mills Cir #7777, Hanover, MD 21076 ("Affiliate").

3. Eligibility Criteria

This Giveaway is open to those who are at least twenty-one (21) years of age at the time of entry and who are Live! Rewards® Members. Participants may be required to show proof of identification (passport, driver's license, or birth certificate) to Sponsor in order to verify eligibility.

The Giveaway is only open to individuals who are physically present in Maryland during the Giveaway Period. If your Social Security number is associated with another PokerStars Account in Sponsor's database, you may only receive one (1) entry with respect to all such accounts participating in this Giveaway.

Employees, officers and directors of Sponsor, its parent companies, and each of their respective affiliates, subsidiaries, cable/satellite affiliates, advertising and promotion agencies, retailers, distributors (collectively, the "Giveaway Entities"), and each of such employees', officers' and directors' immediate family members and/or those living in the same household (whether legally related or not) of each are not eligible to participate in the Giveaway or win. For purposes of this Giveaway, "immediate family members" are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and "those living in the same household" shall mean people

who share the same residence at least three (3) months a year, whether legally related or not.

Maryland Lottery and Gaming Control Agency ("MLGCA") staff, MLGCA agents, and their immediate family members are also ineligible. All excluded patrons, either by self-exclusion or by property, are prohibited from participating and/or winning.

(c) the name you use to participate in the Giveaway must match the name on your Account.

Sponsor may from time to time (including during and/or at any time after the Giveaway) ask you to provide personal details and copies of documentation such as your passport, driving license, other government-issued photo ID, utility bills and/or bank statements to verify eligibility.

4. How to Enter

All first-place winners from Events #1 through #16 of the Maryland State Poker Championship Sponsored by PokerStars Exclusively on FanDuel will automatically receive one (1) entry into the sweepstakes. One drawing ticket will be awarded per event. The winner of event and ticket may decline the sweepstakes entry. If declined, it does not transfer.

Definition of First Place:

First place is defined as the player who wins the highest amount of prize money in the event, excluding bounty winnings.

Chop Situations:

If the remaining prize pool is split evenly among players (an "even chop"), the player with the most chips will be awarded the ticket.

If the prize pool payouts are adjusted within a \$1 difference, i.e. \$3,221 and \$3,220 the chop will still be considered even, and the player with the most chips will be awarded the ticket.

5. Selection of Potential Winner

5.1 Our selection of Winner(s) is final and binding, provided we make our selections in accordance with the Official Rules.

5.2 All eligible entries will be pooled and the Winner will be selected from that pool in accordance with the Winner Selection Method.

5.3 When the original Winner is disqualified, we will select an alternative Winner using the same Winner Selection Method that we used to select the original Winner (with the original Winner's Entry removed from the pool of eligible Entries).

EPT Package value is in euros due to European Main Event buy-in, but values at approx. \$11,500 USD.
