ARTICLE 22.

POSTING OF BOND

The Guild may require the posting of a bond to secure the payment of compensation, including pension, health, vacation pay, residuals, foreign play fees and all other monetary items due or becoming due to Employees in those categories represented by the Guild, and also may impose conditions to secure such payment.
