- DIFC is under no obligation to pre-qualify any applicant or to give reasons for acceptance or rejection.



## Step 1: Supplier Login Registration Screen

### Step 1.1: Register Now (For new Suppliers)

- The Supplier will click on the Supplier registration link which was placed on DIFC site.
