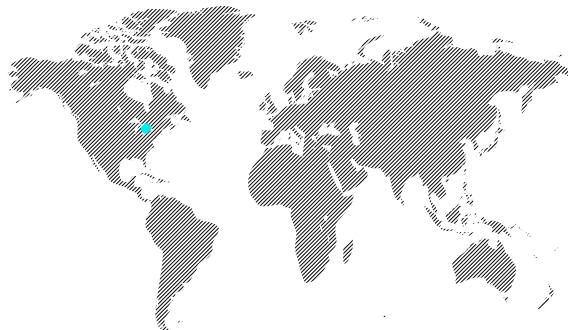
ABOUT RAIVEN CAPITAL
