#### **Description:**

This session will revisit accounting standards that have had a broad impact on the non-profit industry in the last few years. We will discuss the newly effective Current Expected Credit Loss standard (CECL) (ASC 326) and the impacts it may have on your organization. We will also revisit revenue recognition topics in the context of examining revenue sources to help determine donor restrictions or conditional contribution considerations. We will also cover some best practice concepts for tracking and maintaining reporting information. Finally, we will briefly touch on the lease standard that was recently implemented and detail continuing considerations and things to watch for.

- 1. To be able to determine if CECL will have an impact on your organization and if it does, what are your organization's next steps for evaluating your balances under the standard.
- To be able to identify contracts with customers and contribution revenue sources and review for proper revenue recognition within the Organization's financial statements. # **Nonprofit Energy Credits and Incentives**

# **Description:**

The Inflation Reduction Act of 2022 provides significant incentives for renewable and energy efficiency technology investments, ushering in the upcoming Climate Economy. Eide Bailly's Business Credits & Incentives team assists nonprofit organizations to help navigate the potentially \$1.7 trillion in incentives to be given out through 2032. During this session you will learn about those incentives that apply to the NFP Industry, learn who are eligible to participate in the Energy Incentive Program, and where we're seeing the most opportunity.

# **Common Issues Within Charitable Gaming**

# **Description:**

In 1976, the North Dakota constitution was amended to allow certain forms of charitable gaming. Under the provision, the Legislative Assembly is permitted to authorize bona fide nonprofit veterans', charitable, educational, religious, or fraternal organizations, civic and service clubs, or such other public-spirited organizations, to conduct games of chance when the entire net proceeds of the games are devoted to educational, patriotic, fraternal, religious, or other public-spirited uses.

In the recent legislative sessions, many shifts have occurred in this gaming space. These updates and changes for North Dakota will be the topic of this presentation, educating attendees on the size and scope of how one enters Charitable Gaming, conducts it, and how gaming can benefit nonprofits like theirs.
