

Electronic Tax Payment Options

Whether you use the phone app or go online to the IRS website, there are numerous electronic payment options:

IRS Direct Pay

This tool allows individual taxpayers to pay taxes directly from their checking or savings accounts without any fees or pre-registration. It can be accessed through the Internal Revenue Service (IRS) website at <https://www.irs.gov/Payments/Direct-Pay>

Debit, Credit Card and Digital Wallet Options

- **Pay by Debit, Credit Card or Digital Wallet:** Credit or Debit Card Payments: Taxpayers can use IRS-approved credit or debit cards to pay certain types of tax liabilities. However, there may be fees associated with this method.

These processors and fees (updated as of August of 2025) are as follows:

Same-Day Wire: For taxpayers who need to make a payment on the same day, this option is available through their financial institution. However, fees may apply, and there may be specific cut-off times for initiating the transfer.

Download the IRS App!

The IRS has a downloadable app for both iOS and Android phones called IRS2Go. With the app, individuals can access the same payment options available on the IRS website, right from their phone.

General

Most states allow individuals to make income tax payments for free via direct debit or e-check on the state's website or via credit or debit card through a third-party provider who charges a convenience fee.

Some states have cutoff times that they use to determine whether payments were made timely. For example, some states required direct debit from a bank account to be initiated by 5 PM the day before a deadline to be considered paid on time. Please check with the states where payments are due for details.

Alabama

ACH Debit payments must be made through My Alabama Taxes (MAT), you will need your tax account number, sign-on ID, and Access Code.

Alaska

To make a payment, log into your revenue online account. credit card payments are not allowed, and for any payment over \$15,000,000 payment via Wire Transfer is required.

Arizona

Payments via electronic checks do not have a fee but the state will assess a \$50 fee for any returned checks due to incorrect or missing information.

Arkansas

Electronic payments must be made through the Arkansas Taxpayer Access portal and a log in is required.

California

Taxpayers will be subject to a mandatory e-pay penalty for noncompliance with the electronic payment requirements.

Individual taxpayers are required to make electronic payments if either (a) the estimated tax or extension payment is over \$20,000 or (b) an original return is filed with a tax liability over \$80,000.

Only individuals can make payments via pay-by-phone which satisfies the mandatory e-pay requirement for individuals. Taxpayer must submit form FTB 4073 and receive approval to participate in Pay-by-Phone. The state does not charge a fee for using this service.

California

Colorado

Payments via electronic checks are assessed a \$1 fee. Payments via ACH Debit are free, but registration and authorization is required. Payments cannot be made until 24-48 hours after registration.

Credit card payments cannot be cancelled and are subject to a convenience fee.

Electronic payments must be dated at least one business day before the payment deadline.

Georgia

Payments via credit card, PayPal or Venmo will incur a 2.31% convenience fee with a \$1.00 minimum.

Idaho

Idaho offers a quick pay feature where the only option to make a payment is by bank account and no fee is incurred. If payment is made through the taxpayer access point, there is a 2.5% convenience fee on debit or credit card payments.
