1.4 Ancillary network services

Ancillary network services are non-routine services distributors provide to individual customers on an 'as needs' basis.

For the avoidance of doubt, the AER Distribution Determination refers to ancillary network services for which a charge is approved as 'fee-based services'. That is, the fee for the cost of providing the service (labour rates) and the average time to perform the service. These services fees are fixed and apply irrespective of the actual time on-site to perform the service, even if that time varies from the benchmark used in the AER's decision making.

By contrast, quoted services are once-off and specific to a particular customer's request. The cost of these services will depend on the actual time taken to perform the service. With the hourly rate set, the longer it takes the distributor to perform the service, the more the customer will pay.

<p>Preliminary Enquiry Service (Simple or Complex)</p>	<p>Providing prospective connection applicants with specific information and advice in relation to the connection process and requirements associated with establishing a new or altered connection or a relocation of existing network assets. This service is for initial advice and excludes more detailed investigations/advice which may subsequently be required from Strategic Planning Studies and Analysis and Process Facilitation.</p> <p>This service includes an initial site inspection and preparation of a written response addressing the issue(s) queried by the applicant. It may also include an initial customer meeting where requested.</p>

<p>Services involved in obtaining deeds of agreement in relation to property rights associated with contestable connections work</p>	<p>Services related to the acquisition of land interests over, and access to, DNSP assets associated with contestable connection works. New assets being connected to the network may be positioned on land not legally accessible to the DNSP. To ensure the DNSP has appropriate tenure and access to these new assets into the future, a land interest is established in advance of connecting the new assets to facilitate the necessary execution of formal arrangements that create appropriate easement or lease arrangements to be registered on the land title deed.</p> <p>Services provided in relation to obtaining land interests for property rights associated with contestable connection works, including processes associated with obtaining registered leases and easements for land on which DNSP assets are located (i.e. those assets assigned or “gifted” to DNSPs on electrification). These property rights are necessary in order to ensure that the DNSP is able to carry out ongoing maintenance in relation to its assets.</p>

These include:</p> <ul style="list-style-type: none"> • preparing lists of affected sites, and reconciling data with AEMO listings; • handling in-flight transfers; • identifying open service orders raised by the failed Retailer and determining actions to be taken in relation to those service orders; • arranging estimate reads for the date of the RoLR event and providing data for final NUoS bills in relation to affected customers; • preparing final invoices for NUoS and miscellaneous charges for affected customers; • preparing final debt statements; • extracting customer data, providing it to the RoLR and handling subsequent enquiries; • handling adjustments that arise from the use of estimate reads; • assist the Retailer with the provision of network tariffs to be applied and the customer move in process; and • administration of any 'ROLR cost recovery scheme distributor payment determination'.
Cable ID & Spike	<p>Confirmation of identified de-energised cable prior to conducting work.</p>
Planned interruption - customer requested	<p>Where the customer requests to move a planned interruption and agrees to fund the additional cost of performing this distribution service outside of normal business hours.</p>
Private Inspection	<p>Private inspection of privately owned low voltage or high voltage network infrastructure (i.e. privately owned distribution infrastructure before the meter).</p>

Customer initiated Asset Relocations	Relocation of assets that form part of the distribution network in circumstances where the relocation was: <ul style="list-style-type: none"> • initiated by a third party (including a customer); and • could impact the safety or security of the network.
Unlocking secured electrical installation - Site visit	Scheduled attendance to provide third-party access to an electrical installation secured by a DNSP locking system. This service applies if the officer arrives onsite and the MP or other requesting party does not show up within the allotted time or attendance was not actually required.
Unlocking secured electrical installation - Unlock only	Scheduled attendance to provide third-party access to an electrical installation secured by a DNSP locking system. This service applies if the MP or other requesting party arrives within the allotted time and does not require the field officer to remain on site or to relock upon job completion. This fee may also be charged if a defect or other reason preventing planned work from being performed at the installation is immediately identified and the field officer is required to relock.
