


Quick Guide – How To Submit Your New Accreditation for Approval – New ASP Only



Log in to the Beakon Portal

Once you log in to your Dashboard you will see the below screen and the only thing that is visible is your Accreditation under my Assigned Authorisations, this is currently Non-Compliant, to change the status to Compliant you need to submit the Accreditation for Approval. If you do not submit this for approval you will not be able to move to the next step in the process

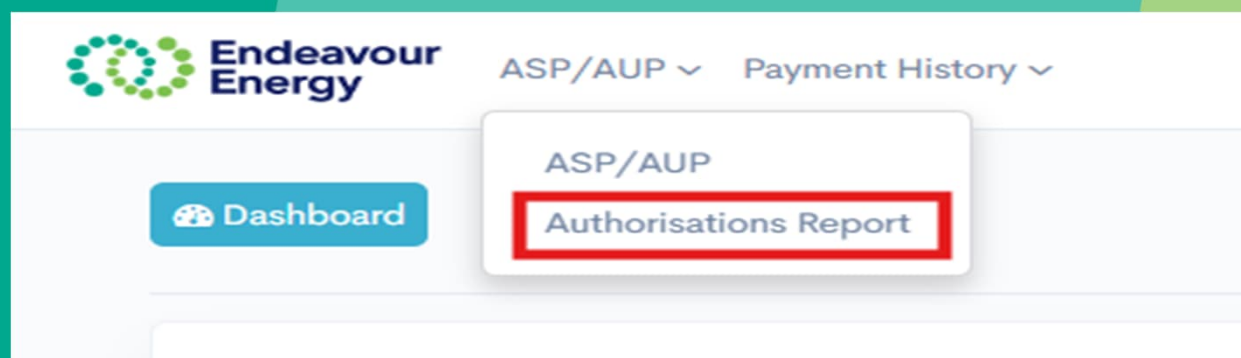


