About this PDS

This Product Disclosure Statement ("PDS") has been prepared and issued by Equity Trustees Limited ("Equity Trustees", "we" or "Responsible Entity") and is a summary of the significant information relating to an investment in the ARGA Global Equity Australia Fund (the "Fund") Class A. It contains a number of references to important information (including a glossary of terms), contained in the Fund's Reference Guide (the "Reference Guide"), and also forms part of this PDS. 1. About Equity Trustees Limited

The Responsible Entity

Equity Trustees Limited ABN 46 004 031 298 AFSL 240975, a subsidiary of EQT Holdings Limited ABN 22 607 797 615, which is a public company listed on the Australian Securities Exchange (ASX: EQT), is the Fund's responsible entity and issuer of this PDS. Established as a trustee and executorial service provider by a special Act of the Victorian Parliament in 1888, today Equity Trustees is a dynamic financial services institution which continues to grow the breadth and quality of products and services on offer.

Equity Trustees' responsibilities and obligations as the Fund's responsible entity are governed by the Fund's constitution ("Constitution"), the Corporations Act and general trust law. Equity Trustees has appointed ARGA Investment Management LP as the investment manager of the Fund. Equity Trustees has appointed a custodian to hold the assets of the Fund. The custodian has no supervisory role in relation to the operation of the Fund and is not responsible for protecting your interests.

The Investment Manager

ARGA is an employee-owned investment management firm focused on global, non-US, and emerging markets equities. ARGA is a classic value manager and seeks to invest in companies which it considers to be undervalued using a disciplined, valuation-based investment approach based on fundamental research and a present value methodology.

ARGA was founded in 2010 by Chief Investment Officer, A. Rama Krishna, who has over 35 years' experience in managing global equities, previously at other well-established investment managers. The firm has grown to over 150 employees in four global locations, managing assets of over USD 18 billion as at January 2025.

2. How the ARGA Global Equity Australia Fund works

The Fund is a registered managed investment scheme governed by the Constitution. The Fund comprises assets which are acquired in accordance with the Fund's investment strategy. Direct investors receive class A units (the "Class") when they invest. In general, each unit represents an equal interest in the assets of the Fund subject to liabilities; however, it does not give investors an interest in any particular asset of the Fund. The constitution allows the Responsible Entity to issue more than one class of units and each separate class may have different rights attached to the units.

If you invest in the Fund through an IDPS you will not become an investor in the Fund. The operator or custodian of the IDPS will be the investor entered in the Fund's register and will be the only person who is able to exercise the rights and receive the benefits of a direct investor. Your investment in the Fund through the IDPS will be governed by the terms of your IDPS. Please direct any queries and requests relating to your investment to your IDPS Operator. Unless otherwise stated, the information in the PDS applies to direct

Applying for units

You can acquire units by completing the Application Form that accompanies this PDS. The minimum initial investment amount for the Class is \$25,000. We may vary or waive the minimum initial investment amount at our discretion and without notice.

Please note that cash and cheques cannot be accepted.

We reserve the right to accept or reject applications in whole or in part at our discretion. We have the discretion to delay processing applications where we believe this to be in the best interest of the Fund's investors.

The price at which units are acquired is determined in accordance with the Constitution ("Application Price"). The Application Price on a Business Day is, in general terms, equal to the Net Asset Value ("NAV") of the Class, divided by the number of units on issue for that class and adjusted for transaction costs ("Buy Spread"). At the date of this PDS, the Buy Spread is 0.20%.

The Application Price will vary as the market value of assets in the Class rises or falls.

No interest is earned on application monies. Fractions of units may be issued by Equity Trustees in accordance with the provisions of the Constitution.

Making additional investments

You can make additional investments into the Class at any time by sending us your additional investment amount together with a completed Application Form. The minimum additional investment into the Fund is \$1,000. We may vary or waive the minimum additional investment amount at our discretion and without notice. You can also increase your units by reinvesting any distributions (see below).

Distributions

An investor's share of any distributable income is calculated in accordance with the Constitution and is generally based on the number of units held by the investor at the end of the distribution

The Class is an accumulating Class and does not intend to distribute on a regular basis. Any distributions will be made on an annual basis. Distributions are calculated effective the last day of the distribution period and are normally paid to investors as soon as practicable after the distribution calculation date.

Investors in the Fund can indicate a preference to have their

- reinvested back into the Fund; or
- directly credited to their AUD Australian domiciled bank account

Investors who do not indicate a preference will have their distributions automatically reinvested. Applications for reinvestment will be taken to be received immediately prior to the next Business Day after the relevant distribution period. There is no Buy Spread on distributions that are reinvested.

In some circumstances, the Constitution may allow for an investor's withdrawal proceeds to be taken to include a component of distributable income.

Indirect Investors should review their IDPS Guide for information on how and when they receive any income distribution.

Access to your money

Investors in the Fund can generally withdraw their investment by completing a written request to withdraw from the Fund and mailing

The minimum withdrawal amount is \$1,000. We may vary or waive the minimum withdrawal amount at our discretion and without notice. Once we receive and accept your withdrawal request, we may act on your instruction without further enquiry if the instruction bears your account number or investor details and your (apparent) signature(s), or your authorised signatory's (apparent) signature(s).

Equity Trustees will generally pay withdrawal proceeds within 7 days of acceptance of a withdrawal request by transferring the withdrawal proceeds to such investor's nominated AUD denominated Australian domiciled bank account. However, Equity Trustees is allowed to reject withdrawal requests, and also to make payment up to 21 days after acceptance of a request (which may be extended in certain circumstances) as outlined in the Constitution and Reference Guide. We reserve the right to accept or reject withdrawal requests in whole or in part at our discretion.

The price at which units are withdrawn is determined in accordance with the Constitution ("Withdrawal Price"). The Withdrawal Price on a Business Day is, in general terms, equal to the NAV of the Class, divided by the number of units on issue in the Class and adjusted for transaction costs ("Sell Spread"). At the date of this PDS, the Sell Spread is 0.15%.

The Withdrawal Price will vary as the market value of assets in the Fund rises or falls.

Equity Trustees reserves the right to fully redeem your investment if your investment balance in the Class falls below \$25,000 as a result of processing your withdrawal request. In certain circumstances, for example, when there is a freeze on withdrawals, where accepting a withdrawal is not in the best interests of investors in the Fund including due to one or more circumstances outside our control or where the Fund is not liquid (as defined in the Corporations Act), Equity Trustees can deny or suspend a withdrawal request and you may not be able to withdraw your funds in the usual processing times or at all. When the Fund is not liquid, an investor can only withdraw when Equity Trustees makes a withdrawal offer to investors in accordance with the Corporations Act. Equity Trustees is not obliged to make such offers.

If you are an Indirect Investor, you need to provide your withdrawal request directly to your IDPS Operator. The time to process a withdrawal request will depend on the particular IDPS Operator and the terms of the IDPS.

Unit pricing discretions policy

Equity Trustees has developed a formal written policy in relation to the guidelines and relevant factors taken into account when exercising any discretion in calculating unit prices (including determining the value of the assets and liabilities). A copy of the policy and, where applicable and to the extent required, any other relevant documents in relation to the policy will be made available free of charge on request.

Additional information

If and when the Fund has 100 or more direct investors, it will be classified by the Corporations Act as a 'disclosing entity'. As a disclosing entity, the Fund will be subject to regular reporting and disclosure obligations. Investors would then have a right to obtain a copy, free of charge, of any of the following documents:

- the most recent annual financial report lodged with ASIC ("Annual Report");
- any subsequent half yearly financial report lodged with ASIC after the lodgement of the Annual Report; and
- any continuous disclosure notices lodged with ASIC after the Annual Report but before the date of this PDS.

Equity Trustees will comply with any continuous disclosure obligation by lodging documents with ASIC as and when required.

3. Benefits of investing in the ARGA Global Equity Australia Fund Class

Significant features

The investment objective of the Fund is to generate long-term returns by investing in listed global equities and equity linked securities of mid- to large-cap global companies that are assessed by the Investment Manager as trading at a discount to their perceived intrinsic value. The Fund's portfolio will generally consist of 45 to 90

The Investment Manager has a team of experienced professionals with a long track record of investing in global equities. The extensive experience of the team is invaluable in identifying and assessing investment opportunities for the Fund.

Significant benefits

ARGA uses a disciplined, repeatable investment process designed minimise biases in all investment decisions. The Fund's investable universe is defined by applying a quantitative screen to identify the relevant companies. The Investment Manager then ranks this group on certain key value metrics and those companies within the top 20% of the ranking are prioritised for further research. Detailed industry and company models are used to evaluate a company's long term earning power and the company's intrinsic value.

Members of the investment team are allocated responsibility for certain global sectors, with each member typically covering two sectors concurrently, and each sector is typically covered by more than one investment professional. By assigning members from multiple office locations (United States, UK, and India) to each global sector, both developed and emerging market perspectives are incorporated into the investment process. The Investment Manager believes that this global perspective is key when analysing any

To facilitate consistency in the Investment Manager's global research efforts, the Investment Manager uses global industry models to understand and evaluate companies. These provide a uniform set of assumptions to use in undertaking any company specific analyses. Additionally, these models provide the necessary framework to quickly evaluate any new companies, which begin to screen cheap (i.e. appear to have an attractive valuation based on the Investment Manager's criteria) in an industry we have already modelled and leverage research - across geographies, industries, companies and

4. Risks of managed investment

All investments carry risks. Different investment strategies may carry different levels of risk, depending on the assets acquired under the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk. The significant risks below should be considered in light of your risk profile when deciding whether to invest in the Fund. Your risk profile will vary depending on a range of factors, including your age, the investment time frame (how long you wish to invest for), your other investments or assets and your risk tolerance.

The Responsible Entity and the Investment Manager do not guarantee the liquidity of the Fund's investments, repayment of capital or any rate of return or the Fund's investment performance. The value of the Fund's investments will vary. Returns are not guaranteed, and you may lose money by investing in the Fund. The level of returns will vary and future returns may differ from past returns. Laws affecting managed investment schemes may change in the future. The structure and administration of the Fund is also subject to change.

In addition, we do not offer advice that takes into account your personal financial situation, including advice about whether the Fund is suitable for your circumstances. If you require personal financial or taxation advice, you should contact a licensed financial adviser and/or taxation adviser.

Equity Risks

The Fund will invest primarily in equity and equity linked securities. The value of these securities generally will vary with the performance of the issuer and movements in the equity markets. As is true of any investment, there is a risk that an investment in the Fund will be lost entirely or in part. The Fund should represent only a portion of an investor's portfolio.

Value Investment Risks

The Investment Manager focuses the Fund's investment strategy on issuers that it believes are undervalued or inexpensive versus other securities or investments. These stocks present risks that are in addition to general equity risks outlined above. When estimating the value of an issuer, the Investment Manager makes assumptions about the fundamentals of the issuer which may be subject to errors in estimation or may be simply proven wrong. Value stocks may also be out of favour for significant periods of time during which time may lead to significant underperformance of the Fund versus certain equity market indices or other investments or strategies.

Risk of Investment in Event Driven Situations

The Fund may invest into companies in financial distress or undergoing a turnaround or issuers that are undervalued because of discrete extraordinary events. Investing in these situations will typically involve a higher degree of risk than investments in other issuers.

Concentration Risk

The Fund's portfolio at times be concentrated. Although concentration may increase the possibility of achieving significant investment returns, concentration of investments in a limited number of issuers, industries or sectors is generally regarded as increasing both relative investment risk and potential portfolio volatility.

General Economic and Market Risk

The success of the Fund's activities will be affected by general economic and market conditions, such as interest rates, availability of credit, inflation rates, economic uncertainty, changes in laws (including laws relating to taxation of the Fund's investments), and national and international political circumstances (including wars, terrorist acts or security operations). These factors may affect the level and volatility of securities prices and the liquidity of the Fund's investments.

Fund Risk

Risks particular to the Fund include that it could terminate, the fees and expenses could change and the service providers of the Fund could change. Investing in the Fund may give different results than investing directly in the underlying assets of the Fund due to income or capital gains treatment or due to the actions of third parties such as other investors.

Investment Manager Risk

There are risks associated with the operational and financial performance of the Investment Manager. In addition, key professionals could change affecting how the Fund is managed.

Currency Risk

The Fund will hold securities denominated in a currency other than Australian Dollars. Any change in the value of these currencies relative to the Australian dollar can impact (positively or negatively) on investment returns. The Investment Manager does not generally hedge the currency exposure in any way.

Counterparty and Third Party Risk

Returns may be affected if counterparties or third parties experience financial difficulty, fail to perform their services or meet their obligations in the manner anticipated by the Fund. Also any failing by a service provider to the Fund could impact on the value of the Fund or ability of an investor to access their investment.

Emerging and Frontier Market Risk

Securities located or doing business in emerging market or frontier countries may involve greater risk of loss and price fluctuation. The market for securities in emerging or frontier markets may be less liquid and more volatile than securities of more mature economies. This means the Fund could have greater difficulty buying or selling a security located or doing business in one of these jurisdictions.

Regulatory and Legal Risk

Governments or regulators may pass laws, create policy, or implement regulation that affects the Fund or its underlying investments or the Investment Manager's ability to execute its investment strategy, for example changes relating to securities transactions or exchange controls. These changes could impact on the value of the Fund's investments.

Cyber Security Risk

The Responsible Entity and Investment Manager as well as other service providers make extensive use of electronic systems. These apply at an investor level, to the Fund's investments and to the operational practices of those involved with the Fund and its investments. While each provider and those with which they do business have safeguards in place, there remains a risk of financial loss, disruption or damage from either internal or external, accidental or malicious conduct targeting of these electronic systems.

Pandemic and other unforeseen event risk

Health crises, such as pandemic and epidemic diseases, as well as other catastrophes that interrupt the expected course of events, such as natural disasters, war or civil disturbance, acts of terrorism, power outages and other unforeseeable and external events, and the public response to or fear of such diseases or events, have and may in the future have an adverse effect on the economies and financial markets either in specific countries or worldwide and consequently on the value of the Fund's investments. Further, under such circumstances the operations, including functions such as trading and valuation, of the Investment Manager, Fund Manager and other service providers could be reduced, delayed, suspended or otherwise disrupted.

Multiple unit class risk

The Fund offers separate classes of units for investment. The classes are not separate legal entities and the assets of each class will not be segregated. All of the assets of the Fund are available to meet all of its liabilities, regardless of the class to which such assets or liabilities are attributable. In practice, cross-class liability will usually only arise where any separate class becomes insolvent and is unable to meet all of its liabilities. In this case, all of the assets of the Fund attributable to other separate classes may be applied to cover the liabilities of the insolvent classes. If losses or liabilities are sustained by a class in excess of the assets attributable to such class, such excess may be apportioned to the other classes.

5. How we invest your money

Warning: When choosing to invest in the Fund or an option of the Fund, you should consider the likely investment returns, the risks of investing and your investment time frame.

Investment objective

The investment objective of the Fund is to generate long-term returns by investing in listed global equities and equity linked securities of mid- to large-cap global companies that are assessed by the Investment Manager as trading at a discount to their perceived intrinsic value.¹

¹Note the investment return objective is not intended to be a forecast. It is merely an indication of what Class A aims to achieve over the medium to long term on the assumption that equity markets remain relatively stable throughout the investment term. The Fund may not be successful in meeting this objective. Returns, capital and income are not guaranteed.

Risk level

Investor suitability

The Fund is generally suited for investors seeking capital appreciation in the medium to long term through exposure to global equities, including emerging market equities. The Fund does not intend to pay out any distributions on a regular basis. Any distributions will be made on an annual basis.

Investment style and approach

The Fund invests in shares of mid- to large-cap global companies. The Fund's portfolio will generally consist of 45 to 90 companies identified using a disciplined, bottom-up, valuation-based investment approach based on fundamental research and a present value methodology. The Investment Manager utilises an initial quantitative screen to first filter the global universe to identify companies with a market capitalisation generally over USD \$1 billion and whose issued securities have a historical 6 month average daily traded value of at least USD\$25million. The Investment Manager then ranks this filtered group on key value metrics including, but not limited to: price to consensus forecast earnings, price to book value, dividend yield, normalised earnings yield (adjusted for return on invested capital). Companies within the top 20% of our screen rankings are prioritised for research by the Investment Manager's investment team. The Investment Manager builds detailed industry and company models to evaluate each company's long-term earnings power. This information is used in the Investment Manager's proprietary modelling to assess a company's intrinsic value and degree of undervaluation for both base case and in a stressed scenario. The Investment Manager will limit risk through undertaking regular stress tests and aiming to have the Fund diversified across industries, geographies and currencies. The Investment Manager assesses quality, ESG and economic conditions that could magnify risk. Portfolio construction is based on research conclusions from the valuation process.

Asset allocation

The Fund will invest in a portfolio of listed equities and equity linked securities which will typically amount to around 95% of the NAV of the Fund, the remainder will be in cash. The securities will be traded on equity markets across the globe, which may include the US, Australia and New Zealand as well as other developed and developing markets. There are no geographical exposure limits but the Fund will not typically invest more than 20% of its assets of the Fund (at the time of purchase) into a single industry and the Investment Manager will reduce positions if the concentration in an industry grows to 30% of the NAV of the Fund. The Fund may invest up to 35% of its assets in emerging markets. The Fund's asset allocation will generally be:

- Listed Equities 95 to 100%
- Cash up to 5%

Changing the investment strategy

The investment strategy and asset allocation parameters may be changed. If a change is to be made, investors in the Fund will be notified in accordance with the Corporations Act.

Labour Standards, Environmental, Social and Ethical Factors ("ESG considerations")

The Fund is not designed for investors who have specific labour standards or environmental, social or ethical (ESG) goals. The integration of ESG considerations into the investment process described below does not imply that the Fund is marketed or authorised as an ESG product in Australia.

Equity Trustees has delegated investment decisions including ESG considerations to the Investment Manager.

The Investment Manager integrates certain ESG considerations in the selection, retention and realisation of fund assets, to the extent that the Investment Manager considers those factors may have a material and quantifiable impact on the investment performance. The Investment Manager defines material ESG factors as those likely to have a significant impact on a company's long-term earnings, cost structure and/or business sustainability. The Investment Manager has developed a global ESG scoring framework which is used to identify potential ESG risks and opportunities at the initial stages of company research. Companies are scored on 13 ESG factors stemming from a larger compilation of ESG metrics using third-party data from reputable sources such as company reports, Bloomberg and CDP (Carbon Disclosure Project). Metric weightings, developed by the Investment Manager, are tailored to sectors - e.g., low emissions score is weighted more for an energy company than technology

The Investment Manager does not pre-define material ESG factors but consider a broad range of metrics including:

- Environmental: resource intensity, emissions intensity, waste management, environmental impact;
- Social: employee retention, diversity and safety, community impact:
- Governance: board independence and diversity, supply chain management, customer management, etc.

Where the impact of ESG factors is deemed material and quantifiable on a company's long-term earnings, the Investment Manager integrates that impact in its long-term forecasts and thereby into its portfolio decision making process. The evaluation of ESG risks and opportunities and implementation of applicable ESG-related investment restrictions rely on availability of timely, complete and accurate ESG data reported by issuers and/or third-party research providers. ESG data is often based on estimates or assumptions. To the extent relevant data is unavailable or inaccurate, Investment Manager's ability to evaluate ESG risks and opportunities and successfully implement applicable ESG-related investment restrictions may be limited. The Investment Manager's ESG Policy is reviewed and revised at least annually or more frequently if necessary. Policy revisions may reflect developments in ESG integration process or revisions in how the Investment Manager communicates its ESG process to clients. The Investment Manager monitors ESG information for portfolio companies on an ongoing basis and reflects any new material and quantifiable ESG factors, in company valuation inputs.

Where the Investment Manager believes that a company has demonstrated wilful disregard for ESG principles, it may choose to avoid or divest on a case by case basis. Where the Investment Manager chooses to divest due to ESG principles, it may do so within a timeframe it considers reasonable in all the circumstances. 6. Fees and costs

DID YOU KNOW?

Small differences in both investment performance and fees and costs can have a substantial impact on your long-term

For example, total annual fees and costs of 2% of your investment balance rather than 1% could reduce your final return by up to 20% over a 30-year period (for example, reduce it from \$100,000 to \$80,000).

You should consider whether features such as superior investment performance or the provision of better member services justify higher fees and costs.

You may be able to negotiate to pay lower fees. Ask the Fund or your financial adviser.

 - i. satisfies one of the 'geographical link' tests in subsection 6(6) of the AML/CTF Act; or
 - ii. has certified in writing to the relevant reporting entity that its name and enrolment details are entered on the Reporting Entities Roll; and
- e) has certified in writing to the relevant reporting entity that it has carried out all applicable customer identification procedures and ongoing customer due diligence requirements in accordance with Chapter 15 of the AML/CTF Rules in relation to its underlying customers prior to, or at the time of, becoming a customer of the reporting entity.
