# 2. Who is managing the Fund

#### The Responsible Trustee

#### **Equity Trustees Limited**

Equity Trustees Limited ABN 46 004 031 298 AFSL No. 240975 ("Equity Trustees"), a subsidiary of EQT Holdings Limited ABN 22 607 797 615, which is a public company listed on the Australian Securities Exchange (ASX: EQT), is the Fund's Trustee and issuer of this IM. Equity Trustees was established in 1888, by an Act of the Victorian Parliament, to provide trustee and executor services.

The company has evolved into a sophisticated financial services provider offering a broad range of products and services to a diverse client base. In addition to traditional trustee and estate management duties, the Equity Trustees range of services includes portfolio management, superannuation, philanthropy and trustee services for external fund managers.

Equity Trustees' responsibilities and obligations as the Trustee of the Fund are governed by the Fund's Constitution as well as general trust law.

#### The Investment Manager

#### Kapstream Capital Pty Limited

Kapstream Capital Pty Limited ABN 19 122 076 117 AFSL 308870 ("Kapstream"), is a wholly-owned subsidiary of Janus Henderson Group plc ("JHG"), a British-American global asset management group headquartered in London. JHG is incorporated in Jersey and is dual-listed on the New York Stock Exchange and the Australian Securities Exchange.

Kapstream was incorporated in Sydney in 2006 and is the leading choice for institutional and individual investors seeking an alternative approach to fixed income, combining capital preservation techniques with unconstrained portfolio management skills in the pursuit of stable, absolute returns.

Kapstream is regulated by ASIC.

In such capacity, the Administrator performs all general administrative tasks for the Fund, including keeping financial books and records and calculating the Net Asset Value of the Fund.

The Trustee has entered into an Administration Agreement with the Administrator which governs the services that will be provided by the Administrator to the Fund.

The Investment Manager may at any time, in consultation with the Trustee, select any other administrator to serve as administrator to the Fund.

#### 3. About the Fund Investments

#### Structure

The Fund is an unregistered managed investment scheme (also known as a managed fund) that is an unlisted Australian unit trust governed by a Constitution together with general trusts laws

#### **Portfolio**

The Fund offers investors access to high yielding investments predominantly in Australian securitised 'warehouse' finance originators. Warehouse financing is a form of private debt securitisation which provides capital to lenders to 'on-lend', and is a critical part of most lending businesses, commonly in the nonbank sector. Underlying borrowers are widely diversified across mortgage, auto, personal, professional, and other receivable and loan types.

#### **Investment Universe**

The Fund will focus predominantly on Australian and New Zealand warehouse securities given the Investment Manager's view that this is a consistently attractive asset class through the cycle. Warehouse originators may offer additional return to investment managers who provide efficient and timely financing. This is because warehouse investments represent a small part of the funding stack for originators. Additionally, they are typically more diversified than other private debt sub-sectors and have a shorter maturity profile, both of which are attractive characteristics in the Investment Manager's opinion.

#### Objective of the Fund

The Fund aims to provide relatively high and consistent monthly income with capital stability, while aiming to outperform the RBA Official Cash Rate by 6% p.a. over rolling three-year periods (before fees).

#### Why invest in the Fund?

The Fund is suitable for investors seeking a diversified and conservative private debt investment, a high-yielding low volatility 'defensive alternatives' investment, or an illiquid higher-yielding complement to conventional fixed income allocations.

The Investment Manager believes that a diversified and actively managed portfolio focused predominantly on investments in Australian and New Zealand securitised 'warehouse' finance

originators provides investors with the opportunity to earn a high and consistent income return with low volatility that exploits the attractive illiquidity premia available from private debt investments. Warehouse finance investments typically offer greater diversification, higher average quality, and are typically shorter dated, when compared to other sectors of the private debt investment universe.

#### Portfolio Construction

The Fund fundamentally seeks to exploit the high illiquidity premia that exist in warehouse investments versus comparable public securitised investments, but will also maintain a constant but minor exposure to more liquid assets (detailed under 'Portfolio Parameters' below) to provide some liquidity to investors who may wish to make occasional withdrawals from the Fund.

#### Specialised Investments Area

The Fund provides investors with access to 'warehouse' finance originators, a specialised sub-sector of the private debt investment universe with typically few participants owing to the often high barriers to entry.

#### Investment Parameters of the Fund

#### Portfolio Parameters

The Investment Manager will aim to invest 90% of the NAV of the Fund in warehouse finance investments, and 80% of those aimed to be of Australian or New Zealand domicile, and will typically limit exposure to any one individual issue to 25% of the Fund's NAV.

For overall Fund liquidity purposes, the Fund will aim to invest 10% of the NAV of the Fund in more liquid investments (such as public securitised assets, corporate and government bonds, cash and deposits).

The Fund is permitted to use derivatives for risk management purposes. The Fund will not borrow on or leverage the portfolio except for liquidity management purposes, or in exceptional circumstances where the Investment Manager considers it to be in the best interest of investors.

## 4. Principal risks

All investments carry risks. Different investment strategies may carry different levels of risk, depending on the assets acquired under the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk. You should consider the significant risks below when deciding whether to invest in the Class. You may want to consider these risks in light of your risk profile. Your risk profile will vary depending on a range of factors, including your age, the investment time frame (how long you wish to invest for), your other investments or assets and your risk tolerance.

You may lose money by investing in the Class and your investment in the Class may not meet your objectives. The level of returns will vary and future returns may differ from past returns. Laws affecting managed investment schemes may also change in the future.

Exposure and issuer concentration limits determined through the Investment Manager's risk management approach provide a framework for the amount of credit risk within the Fund, and this risk can be mitigated through the use of hedging tools such as credit derivatives; the maintenance of effective portfolio diversification; and the focus on high quality assets.

Liquidity Risk is the risk that the securities in which the Fund is invested, or the Fund itself, may become illiquid, and is another primary risk of the Fund. This may also impact an investor's ability to withdraw from the Class. A significant proportion of the Fund's assets are unlisted, meaning that there is no guarantee there will be a market for the sale of the Fund's assets (see Section 5 under Withdrawals and Section 6 Fees and other costs for specific information relating to withdrawal terms and conditions). The Investment Manager aims to mitigate this risk in a number of ways, including the following: by maintaining effective portfolio diversification such that the inability to liquidate any one specific asset at a reasonable price does not materially impact the performance and liquidity of the whole Fund; for the majority of the Fund's assets, by including transferor provisions within underlying asset documentation to enable the transfer of particular assets of the Investment Manager's choosing out of the Fund to a pre-determined list of other market participants and/or other portfolios managed by the Investment Manager, without the need to obtain permission of the asset originator; by focusing the majority of investments on shorter-dated assets where assets mature more frequently creating natural portfolio liquidity; and by maintaining a minority exposure within the Fund to more liquid assets, including cash, at all times.

Interest Rate Risk is the risk of loss incurred by fixed income securities due to a change in the level of interest rates, In general, as interest rates rise, the price of fixed rate securities will fall. The Investment Manager seeks to reduce this risk by focusing the Fund's investments predominantly on assets issued with a floating rate, and therefore where the price impact of a

change to interest rates is mitigated. Where the Fund holds assets with fixed rates, the Investment Manager may hedge interest rate risk though the use of interest rate derivatives.

Rating Risk is the risk of failure of either an external agency rating or internal manager rating to correctly reflect the quality of an issuer of assets in which the Fund invests. The Fund predominantly invests in assets that do not have an external agency rating and instead rely on an internal manager rating. A rating overstating the quality of an issuer could lead to higher unintended credit risk being taken by the Fund which may adversely affect the value or liquidity of specific assets in the Fund or the Fund itself. The risk is mitigated by the Investment Manager maintaining portfolio diversification, and risk controls around its Manager Rating Policy, which itself is based on external agency rating methodology. In the case of assets held by the Fund which have an external agency rating, the lower of the rating agency ratings available is used.

Economic Risk is the risk that certain events beyond the Investment Manager's control may cause a deterioration in general economic conditions which may adversely affect the value and liquidity of the Fund's assets. Economic risk may also be associated with other risks described on this page, such as interest rate and currency risk.

Concentration Risk is the risk of a material impact to the value or liquidity of the Fund caused by lack of portfolio diversification. The Investment Manager aims to mitigate this risk by adhering to minimum diversification levels and limits on individual asset exposure, to avoid the materiality of the impact on the whole Fund should any individual asset underperform.

Geographic Concentration Risk. To the extent the Fund invests a substantial amount of its assets in issuers located in a single country or region, the economic, political, social, regulatory, or other developments or conditions within such country or region will generally have a greater effect on the value or liquidity of the Fund than they would on a more geographically diversified fund. Adverse developments in certain regions could also adversely affect securities of other countries whose economies appear to be unrelated and could have a negative impact on the Class' performance. The Fund's investment in Australian and New Zealand issuers may subject the Class to loss in the event of adverse tax, political, economic, regulatory, and other developments that affect Australia and New Zealand and their debt markets, including fluctuations of Australian and New Zealand currencies. Also, Australia and New Zealand are economically sensitive to environmental events and are located in a part of the world that has historically been prone to natural disasters, such as drought and flooding. The Investment Manager aims to mitigate this concentration risk by careful selection of investments to minimise these risks.

Currency Risk is the risk that the value of any non-Australian dollar assets held within the Fund and attributable to the Class may be negatively affected by any variation in the foreign exchange rate between the currency denomination of those foreign assets and the Australian dollar, being the underlying Fund currency. This risk is expected to be minimal as the Fund focused predominantly Australian dollar-denominated assets. Where the Fund does invest in non-Australian dollar securities, the Investment Manager will aim to mitigate any currency risk through the use of currency derivatives such as swaps or foreign exchange forwards.

Derivative Risk is expected to be low within the Fund, which is permitted to use derivatives for risk hedging purposes only, and therefore will be maintained at a low exposure level. Derivatives may lose value and therefore may impact the value of the Fund, but the Investment Manager aims to mitigate this by avoiding the use of derivatives to leverage the Fund and by avoiding structures where the loss can exceed the initial investment.

Inflation Risk is the risk that inflation may erode the real value of the return of the Fund. This is expected to be minimal as the Investment Manager invests predominantly in assets with floating (not fixed) interest rates. Typically, when inflation rises, so to do interest rates and the coupons from floating rate fixed income securities.

Counterparty and Service Provider Risk is the risk that a counterparty or service provider fails to meet contractual obligations in relation their responsibilities to assets within the Fund or the Fund itself causing loss or disruption to the Fund or the Class. The Investment Manager and Trustee aim to mitigate this risk through the careful selection and due diligence of counterparties and service providers, and by ongoing monitoring of performance.

Regulatory and Tax Risk is the risk that a government, regulator, or operator of a securities or asset exchange makes tax or regulatory changes that have an adverse impact on the value of assets held within the Fund or the ability for the Investment Manager to manage the Fund.

Fund Risk is the risk that the Fund itself could be caused to terminate, that fees and expenses could change, or that the Trustee or Investment Manager could be replaced.

Valuation Risk is the risk common with investments that are not exchange-traded, which the Fund predominantly invests in, where the Fund relies on a third party to value assets, based on

observable market data and prices for comparable assets. Failure to be able to obtain a reliable valuation for a particular asset or assets may have an impact on the value of the Fund or the Class. This risk is not considered significant as the Investment Manager focuses on short-dated assets with typically low price volatility.

Manager Risk and Key Person Risk is the risk that the Fund may fail to meet its objectives due to deviation from the Fund guidelines by the Investment Manager, or a change to the team responsible for managing the Fund. This risk is mitigated by ensuring robust trade compliance controls and by effective deputization and succession planning by the Investment Manager to ensure management experience and skill is maintained constantly at a high level.

Pandemic Risk includes health crises, such as pandemic and epidemic diseases, as well as other catastrophes that interrupt the expected course of events, such as natural disasters, war or civil disturbance, acts of terrorism, power outages and other unforeseeable and external events, and the public response to or fear of such diseases or events, and may in the future have an adverse effect on the economies and financial markets either in specific countries or worldwide and consequently on the value of the Fund's investments. Further, under such circumstances the operations, including functions such as trading and valuation, of the Investment Manager, Fund Manager and other service providers could be reduced, delayed, suspended or otherwise disrupted.

# 5. Investing in the Fund

#### **Authorised Investments**

The Fund can only invest in assets permitted by the Constitution.

#### **Valuations**

The assets of the Fund will be valued independently by ICE and/or other reputable third parties who provide valuations where these are available. Where these are not available the Fund's investments may be valued by the Investment Manager or another party in accordance with generally accepted valuation principles and the Constitution.

#### **Applications**

You can acquire units in the Class by completing the Application Form that accompanies this Information Memorandum together with written notice of the deposit details into the Fund's application account. Refer to Section 7.3 of the Fund Application Form for the account details and instructions on how to instruct your banking institution to facilitate payment to the Fund bank account. Funds need to be deposited into the Fund's application account at the same time you lodge the Application Form with Equity Trustees.

Please note that cash and cheques cannot be accepted.

All applications will be processed monthly using the month end unit price applicable to the Class. Applications are processed on the last Business Day of each month (the "application date").

Applications may only be made by a Wholesale Client.

The minimum initial application for units is \$100,000. Equity Trustees reserves the right to accept lesser amounts.

The price at which units are acquired is determined in accordance with the Constitution ("Application Price"). The Application Price on a Business Day is, in general terms, equal to the NAV of the Class, divided by the number of units on issue in the Class and adjusted for transaction costs ("Buy Spread"). At the date of this IM, the Buy Spread is zero. The Application Price will vary as the market value of assets in the Fund associated with the Class rises or falls.

If we receive a correctly completed application form, identification documents (if applicable) and cleared application money:

- before or at 2.00pm (Sydney time) on the final Business Day of a calendar month and your application for units is accepted, you will receive the Application Price calculated for that Business Day; or
- after 2.00pm (Sydney time) on the final Business Day of a calendar month, your application will be considered in respect of (and, if your application for units is accepted, you will receive the Application Price calculated in respect of) the last Business Day in the immediately following month.

#### Additional applications

Unitholders can apply for additional units. There is no minimum additional investment amount and as such, the acceptance of additional applications is determined by the Trustee from time to time. Additional applications can be made by post, email or fax.

If payment is made by way of electronic transfer, then you must complete and duly sign the Application Form and mail it to:

#### Terms and conditions for applications

Under the Anti-Money Laundering and Counter-Terrorism Financing Act 2006 and the Foreign Account Tax Compliance Act (FATCA) applications made without providing all the information and supporting identification documentation requested on the Application Form cannot be processed until all the necessary information has been provided. As a result, delays in processing your application may occur.

Equity Trustees reserves the right to refuse any application without giving a reason. If for any reason Equity Trustees or the Administrator refuses or is unable to process your application to invest in the Fund, the Administrator will return your application money to you, subject to regulatory considerations, less any taxes or bank fees in connection with the application. You will not be entitled to any interest on your application money in this circumstance.

#### Withdrawals

The Fund allows for up to 5% of the Fund NAV to be withdrawn each calendar quarter, with aggregate investor withdrawals exceeding 5% in any given calendar quarter scaled on a pro-rata basis. The Trustee has an ongoing obligation to review this 5% threshold and determine whether it is in Fund members' best interests for it to be increased.

Equity Trustees must be notified in writing by giving at least 30 days' notice of a withdrawal. All withdrawals will be processed quarterly using the month end unit price for the Class at the end of each calendar quarter. Withdrawals are processed on the last Business Day of each calendar quarter following expiration of the 30 day notice period.

If we receive a withdrawal request:

- before 2.00pm (Sydney time) on the final Business Day of a calendar quarter and your withdrawal request is accepted, you will receive the withdrawal price calculated for that Business Day; or
- on or after 2.00pm (Sydney time) on the final Business Day of a calendar quarter, your request will be considered in respect of (and, if your withdrawal request is accepted, you will receive the Withdrawal Price calculated in respect of) the end of the immediately following quarter.

We reserve the right to accept or reject withdrawal requests in whole or in part at our discretion. We have the discretion to delay processing withdrawal requests where we believe this to be in the best interest of the Fund's investors.

The minimum withdrawal is \$100,000, which may in certain circumstances be waived by the Trustee (or the total of a Unitholder's entire holding, if less). Equity Trustees is unable to accede to a withdrawal request if the Fund is not liquid however, it will make reasonable endeavours to pay the withdrawal as soon as is reasonably practicable without materially adversely impacting remaining Unitholders.

Equity Trustees will generally transfer the withdrawal proceeds associated with an accepted withdrawal application to such investor's nominated Australian domiciled bank account within 21 days. However, the Constitution allows Equity Trustees to reject withdrawal requests and to delay withdrawals or calculation of the Withdrawal Price, in certain circumstances. The price at which units in the Class are withdrawal Price"). The

Withdrawal Price on a Business Day is, in general terms, equal to the NAV of the Class, divided by the number of units on issue in the Class and adjusted for transaction costs ("Sell Spread"). At the date of this IM, the Sell Spread is 0.2%. The Withdrawal Price will vary as the market value of assets in the Fund associated with the Class rises or falls.

The minimum required investment balance is \$100,000. The Trustee reserves the right to alter or waive this minimum. Equity Trustees reserves the right to fully redeem your investment if vour investment balance in the Fund falls below an amount determined by the Trustee as a result of processing your withdrawal request. Equity Trustees can deny a withdrawal request in certain circumstances, including where accepting the request is not in the best interests of investors in the Fund or where the Fund is not liquid (as defined in the Corporations Act).

#### **Income Distributions**

An investor's share of any distributable income is calculated in accordance with the Constitution and is generally based on the number of units in the Class held by the investor at the end of the distribution period.

The Fund usually distributes income monthly. Distributions are calculated on the last day of the period and are normally paid to investors as soon as practicable after the distribution calculation date

Investors in the Class can indicate a preference to have their distribution:

reinvested back into the Class; or

directly credited to their nominated Australian domiciled bank account

Investors who do not indicate a preference will have their distributions automatically reinvested. Applications for reinvestment will be taken to be received prior to the next valuation time after the relevant distribution period. There is no Buy Spread on distributions that are reinvested. In some circumstances, an investor's withdrawal proceeds may be taken to include a component of distributable income.

#### Reporting

Unitholders will receive the NAV of the Class and performance reviews on a monthly basis and yearly audited reports.

#### Rights and Liabilities of Unitholders

Rights of the Unitholders are governed by the Constitution and general trusts laws. The Constitution provides that a Unitholder's liability to the Trustee is generally limited to the amount, if any, that remains unpaid in connection with an application by the Unitholder to acquire Units.

#### 6. Fees and other costs

#### Management costs

Management costs include management fees and other ordinary expense recoveries related to the establishment and operation of the Fund. Management costs do not include transaction costs and abnormal expenses, which may also be charged to the Fund.

The management fees include Trustee fees, investment management fees administration fees and bank fees. The management fees are 0.65%p.a. (excluding GST and before taking into account RITC) of the NAV of the Class and are reflected in the unit price of the Class.

All other ordinary expenses related to the establishment and operation of the Fund, including legal costs, due diligence costs, custody fees and auditing and tax fees, are separately recovered from the Fund.

#### Further information regarding fees and other costs

#### What do the management costs pay for?

The management fees include Trustee fees, investment management fees, administration fees and bank fees. The management fees are calculated and accrued monthly based on the NAV of the Class. The accrued fees are paid in arrears from the assets of the Class within 14 days of the end of each month. The management fees reduce the NAV of the Class and are reflected in the unit price for the Class.

All other ordinary expenses related to the establishment and operation of the Fund, including custody fees and auditing and tax fees, are separately recovered from the Fund outside of the management fees.

#### Differential fees

From time to time the Investment Manager may negotiate fees that differ from those above. This will generally relate to the size of your investment in the Class or the Fund. Please contact the Investment Manager if you wish to discuss the fees that may apply to your investment.

#### Transaction and other costs

In managing the assets of the Fund, the Fund may incur transaction costs such as brokerage, settlement costs, clearing costs and applicable stamp duty when assets are bought and

sold. This generally happens when the assets of a fund are changed in connection with day-to-day trading or when there are applications or withdrawals which cause net cash flows into or out of a fund.

All government taxes such as stamp duty and GST will be deducted from the Fund as appropriate. RITCs will also be claimed by the Fund where appropriate to reduce the cost of GST to the Fund.

#### Buy/Sell Spread

The Buy/Sell Spread reflects the estimated transaction costs associated with buying and selling the assets of the Fund when Unitholders invest in, or redeem from, the Fund. The Buy/Sell Spread is an additional cost to the Unitholder but is included in the unit price and incurred when a Unitholder invests in or redeems units from the Class and is not charged as an additional fee. Investors should be aware that Spreads may rise (or fall) materially should market or Fund conditions require.

The Buy/Sell Spread is paid into the Fund and not retained by Equity Trustees or the Investment Manager. At the date of this IM, the Buy/Sell Spread for the Fund is 0%/-0.2%.

#### Abnormal expenses

In addition to the management fees and ordinary expense recoveries, the Trustee may additionally recover abnormal expenses (such as the costs of Unitholders' meetings, legal advice/proceedings and other irregular expenses). The Constitution does not place any limit on the amount of the abnormal expenses that can be paid from the Fund.

#### Can the fees change?

All fees can change without Unitholder consent, subject to the maximum fee amounts specified in the Constitution of the Fund. Reasons might include changing economic conditions and changes in regulation. Equity Trustees have the right to recover all proper expenses incurred in managing the Fund and as such these expenses may increase or decrease accordingly. We will notify Unitholders of any changes to fees and expenses in accordance with the law and the Constitution. The Constitution in some circumstances defines the maximum fees that can be charged for some fees described in this IM.

# 7. Other Important Information

#### Cooling off period

No cooling off period applies to units offered under this IM.

#### Unitholder's liability

The Constitution for the Fund provides that unless there is a separate agreement with a Unitholder, no Unitholder can be called on to contribute to the assets of the Fund or to its creditors if the Fund is liquidated or becomes insolvent. Therefore, it is expected that Unitholders will not be under any obligation if a deficiency in the assets of the Fund was to occur. However, this view has not been fully tested and so it is not possible to give an absolute assurance that a Unitholder's liability will be limited in all circumstances.

In general, the liability of a Unitholder is limited to the amount (if any) which remains unpaid in relation to their subscription for units and certain amounts in respect of tax. The Trustee is permitted to deduct certain amounts owed to the Trustee from amounts payable to Unitholders.

#### Non-listing of units

The units of the Fund are not listed on any stock exchange and no application will be made to list the units of the Fund on any stock exchange.

#### Termination of the Fund

The Trustee may resolve at any time to terminate, liquidate and wind up the Fund in accordance with the Fund's Constitution. The Fund may otherwise terminate if required by law. A notice will be provided to Unitholders advising of the Fund's termination. Upon termination and after conversion of Fund assets into cash and payment of, or provision for, all costs and liabilities (actual and anticipated), the net proceeds will be distributed pro-rata amongst all Unitholders according to the number of units they hold in the Fund.

#### Compliance Plan

Equity Trustees has prepared and lodged a compliance plan for the Fund with ASIC. The compliance plan describes the procedures used by Equity Trustees to comply with the Corporations Act and the Constitution of the Fund. Each year the compliance plan for the Fund is audited and the audit report is lodged with ASIC.

#### **Unit Pricing Discretions Policy**

Equity Trustees has developed a formal written policy in relation to the guidelines and relevant factors taken into account when exercising any discretion in calculating unit prices (including determining the value of assets and liabilities). A copy of the policy and, where applicable and to the extent required, any other relevant documents in relation to the policy (such as records of any discretions which are outside the scope of, or inconsistent with, the unit pricing policy) will be made available to investors free of charge on request.

#### Joint Account Operation

For joint accounts, unless indicated to the contrary on the Application Form, each signatory must sign withdrawal requests. Please ensure all signatories sign the declaration in the Application Form. Joint accounts will be held as joint tenants unless we are advised to the contrary in writing.

#### Appointment of Authorised Nominee to Operate Account

You can appoint a person, partnership or company as your authorised signatory. To do so, please nominate them on the

initial Application Form and have them sign the relevant sections. If a company is appointed, the powers extend to any director and officer of the company. If a partnership is appointed, the powers extend to all partners. Such appointments will only be cancelled or changed once we receive written instructions from you to do so.

Once appointed, your authorised signatory has full access to operate your investment account for and on your behalf. This includes the following:

- making additional investments;
- requesting income distribution instructions to be changed;
- withdrawing all or part of your investment;
- changing bank account details;
- enquiring and obtaining copies of the status of your investment; and
- having online account access to your investment.

If you do appoint an authorised signatory:

- you are bound by their acts;
- you release, discharge and indemnify us from and against any losses, liabilities, actions, proceedings, account claims and demands arising from instructions received from your authorised representatives; and
- you agree that any instructions received from your authorised representative shall be complete satisfaction of our obligations, even if the instructions were made without your knowledge or authority.

#### **Electronic Instructions**

If an investor instructs Equity Trustees by electronic means, such as facsimile, email or via the internet the investor releases Equity Trustees from and indemnifies Equity Trustees against, all losses and liabilities arising from any payment or action Equity Trustees makes based on any instruction (even if not genuine):

- Trustees receives by an electronic Equity communication bearing the investor's investor code; and
- which appears to indicate to Equity Trustees that the communication has been provided by the investor (for example, it has. a signature which is apparently the investor's or an authorised signatory's or it has an email address which is apparently the investor's).

The investor agrees that neither the investor nor anyone claiming through the investor has any claim against Equity Trustees or the Fund in relation to such payments or actions.

There is a risk that a fraudulent withdrawal request can be made by someone who has access to an investor's investor code and a copy of their signature or email address. Please take care.

#### Constitution of the Fund

You will be issued units in the Fund when you invest. Each unit represents an equal undivided fractional beneficial interest in the assets of the Fund as a whole subject to liabilities, but does not give you an interest in any particular property of the Fund.

Equity Trustees' responsibilities and obligations, as the Trustee of the Fund, are governed by the Constitution as well as general trust law. The Constitution contains a number of provisions relating to the rights, terms, conditions and obligations imposed on both Equity Trustees, as the Trustee of the Fund, and investors. Some of the provisions of the Constitution are discussed elsewhere in this IM.

Other provisions relate to an investor's rights under the Constitution, and include:

- an investor's right to share in any Fund income, and how we
- what you are entitled to receive when you withdraw or if the Fund is wound up;
- an investor's right to withdraw from the Fund subject to the times when we can cease processing withdrawals, such as if the Fund becomes 'illiquid';
- the nature of the units identical rights attach to all units;
- an investor's rights to attend and vote at meetings.

There are also provisions governing our powers and duties, including:

- how we calculate unit prices, the maximum amount of fees we can charge and expenses we can recover;
- when we can amend the Constitution generally we can only amend the Constitution where we reasonably believe that the changes will not adversely affect investors' rights. Otherwise the Constitution can only be amended if approved at a meeting of investors;
- when we can retire as the Trustee of the Fund;
- when we can be removed as the Trustee of the Fund which is when required by law; and
- our broad powers to invest, borrow and generally manage the Fund

The Constitution also deals with our liabilities in relation to the Fund and when we can be reimbursed out of the Fund's assets.

For example:

- subject to the Corporations Act we are not liable for acting in reliance and good faith on professional advice;
- subject to the Corporations Act we are not liable for any loss unless we fail to act in good faith or we act negligently; and
- we can be reimbursed for any liabilities we incur in connection with the proper performance of our powers and duties in respect of the Fund.

As mentioned above, Equity Trustees' responsibilities and obligations as the Trustee of the Fund are governed by the Constitution of the Fund and general trust law which require that we:

- act in the best interests of investors and, if there is a conflict between investors' interests and our own, give priority to
- ensure the property of the Fund is clearly identified, held separately from other funds and our assets, and is valued regularly;
- ensure payments from the Fund's property are made in accordance with the Constitution and the Corporations Act; and
- report to ASIC any breach of the Corporations Act in relation to the Fund which has had, or is likely to have, a materially adverse effect on investors' interests.

Copies of the Constitution are available, free of charge, on request from Equity Trustees.

#### Indemnity

Equity Trustees, as the Trustee of the Fund, is indemnified out of the Fund against all liabilities incurred by it in properly performing or exercising any of its powers or duties in relation to the Fund. To the extent permitted by law, this indemnity includes any liability incurred as a result of any act or omission of a delegate or agent appointed by the Trustee. Equity Trustees may retain and pay out any monies in its hands all sums necessary to effect such an indemnity.

#### Related party transactions

The Trustee and its associates are entitled to enter into or be interested on their own account in any transactions entered into on behalf of the Fund or with any company or body in which the Fund is invested or who provides services to the Fund. Any such transactions will be on arm's length commercial terms. The Trustee and its associates are also permitted to hold units in any capacity.

#### **Investment Manager consents**

Kapstream has given, and at the date of this IM has not withdrawn, its written consent:

- to be named in this IM as the Investment Manager of the Fund; an
- to the inclusion of the statements made about it, the Fund, the investment strategy of the Fund and to the statistical information attributed to it in the form and context in which this information appears.

Kapstream has not otherwise been involved in the preparation of this IM, nor has it caused or otherwise authorised the issue of this IM. Neither Kapstream nor their employees or officers accept any responsibility arising in any way for errors or omissions from this IM, other than in relation to the statements for which they have provided consent.

#### Administrator consents

Artega has given, and at the date of this IM has not withdrawn, its written consent:

- to be named in this IM as the Administrator of the Fund; and
- to the inclusion of the statements made about it and the Fund in the form and context in which this information appears.

Artega has not otherwise been involved in the preparation of this IM, nor have they caused or otherwise authorised the issue of this IM. Neither Artega nor their employees or officers accept any responsibility arising in any way for errors or omissions from this IM, other than in relation to the statements for which they have provided consent.

#### Registry consents

BoardRoom Pty Limited (BoardRoom) has given, and at the date of this IM has not withdrawn, its written consent:

#### Foreign Account Tax Compliance Act ("FATCA")

In April 2014, the Australian Government signed an intergovernmental agreement ("IGA") with the United States of America ("U.S."), which requires all Australian financial institutions to comply with the FATCA Act enacted by the U.S. in

Under FATCA, Australian financial institutions are required to collect and review their information to identify U.S. residents that invest in assets through non-U.S. entities. This information is reported to the Australian Taxation Office ("ATO"). The ATO may then pass that information onto the U.S. Internal Revenue Service.

In order to comply with the FATCA obligations, we may request certain information from you. Failure to comply with FATCA obligations may result in the Fund, to the extent relevant, being subject to a 30% withholding tax on payment of U.S. income or gross proceeds from the sale of certain U.S. investments. If the Fund suffers any amount of FATCA withholding and is unable to obtain a refund for the amounts withheld, we will not be required to compensate Unitholders for any such withholding and the effect of the amounts withheld will be reflected in the returns of the Fund.

#### Common Reporting Standard ("CRS")

The CRS is a standardised set of rules developed by the Organisation of Economic Co-operation and Development that requires certain financial institutions resident in a participating jurisdiction to document and identify reportable accounts and implement due diligence procedures. These financial institutions will also be required to report certain information on reportable accounts to their relevant local tax authorities.

Australia signed the CRS Multilateral Competent Authority Agreement and has enacted provisions within the domestic tax legislation to implement CRS in Australia. Australian financial institutions need to document and identify reportable accounts, implement due diligence procedures and report certain information with respect to reportable accounts to the ATO. The ATO may then exchange this information with foreign tax authorities in the relevant signatory countries.

In order to comply with the CRS obligations, we may request certain information from you. Unlike FATCA, there is no withholding tax that is applicable under CRS. However, penalties may apply for failing to comply with the CRS obligations.

#### Anti-Money Laundering and Counter Terrorism Financing ("AML/CTF")

Australia's AML/CTF laws require Equity Trustees to adopt and maintain a written AML/CTF Program. A fundamental part of the AML/CTF Program is that Equity Trustees must hold up-to-date information about investors (including beneficial owner information) in the Fund.

To meet this legal requirement, we need to collect certain identification information (including beneficial owner information) and documentation ("KYC Documents") from new investors. - e) has certified in writing to the relevant reporting entity that it has carried out all applicable customer identification procedures and ongoing customer due diligence requirements in accordance with Chapter 15 of the AML/CTF Rules in relation to its underlying customers prior to, or at the time of, becoming a customer of the reporting entity.
