The Responsible Entity

Equity Trustees Limited

Equity Trustees Limited ABN 46 004 031 298 AFSL 240975, a subsidiary of EQT Holdings Limited ABN 22 607 797 615, which is a public company listed on the Australian Securities Exchange (ASX: EQT), is the Fund's responsible entity and issuer of this PDS. Established as a trustee and executorial service provider by a special Act of the Victorian Parliament in 1888, today Equity Trustees is a dynamic financial services institution which continues to grow the breadth and quality of products and services on offer.

Equity Trustees' responsibilities and obligations as the Fund's responsible entity are governed by the Fund's constitution ("Constitution"), the Corporations Act and general trust law. Equity Trustees has appointed Neuberger Berman Australia Ltd ("Neuberger Berman Australia" or "Investment Manager") as the investment manager of the Fund. Equity Trustees has appointed a custodian to hold the assets of the Fund. The custodian has no supervisory role in relation to the operation of the Fund and is not responsible for protecting your interests.

Investment Manager

Neuberger Berman Australia

Neuberger Berman Australia is the manager of the Fund. It operates under an Australian Financial Services License (AFSL 391401) and, as a wholly owned subsidiary of Neuberger Berman Group LLC, is part of Neuberger Berman.

Founded in 1939, Neuberger Berman is a private, independent, employee-owned global asset management firm with a primary objective: to deliver compelling investment results for its clients over the long term. From offices in 26 countries, and with more than 700 investment professionals and over 2,600 employees in total, Neuberger Berman takes an active approach to the management of equity, fixed income, private equity and debt, hedge fund and quantitative strategies, along with the multi-asset class portfolios that bring them together. As of 30 September 2022, institutions, advisors, families and individuals around the globe have entrusted Neuberger Berman with US\$408 billion of their assets.

2. How the Neuberger Berman Strategic Income Fund - I Class works

The Fund is a registered managed investment scheme governed by the Constitution. The Fund comprises assets which are acquired in accordance with the Fund's investment strategy. Direct investors receive units in the Class when they invest. In general, each unit represents an equal interest in the assets of the Class subject to liabilities; however, it does not give investors an interest in any particular asset of the Class.

If you invest in the Fund through an IDPS (as defined in the Reference Guide) you will not become a unitholder in the Fund. The operator or custodian of the IDPS will be the unitholder entered in the Fund's register and will be the only person who is able to exercise the rights and receive the benefits of a unitholder. Please direct any queries and requests relating to your investment to your IDPS Operator. Unless otherwise stated, the information in this PDS applies to direct investors.

Applying for units

You can acquire units by completing the Application Form that accompanies this PDS. The minimum initial investment amount for the Class is \$500,000, which may be waived in our absolute discretion.

Please note that cash and cheques cannot be accepted.

We reserve the right to accept or reject applications in whole or in part at our discretion. We have the discretion to delay processing applications where we believe this to be in the best interest of the Fund's investors.

The price at which units are acquired is determined in accordance with the Constitution ("Application Price"). The Application Price on a Business Day is, in general terms, equal to the Net Asset Value ("NAV") of the Class, divided by the number of units on issue and adjusted for transaction costs ("Buy Spread"). At the date of this PDS, the Buy Spread is 0.10%.

The Application Price will vary as the market value of assets in the Class rises or falls.

Making additional investments

You can make additional investments into the Class at any time by sending us your additional investment amount together with a completed Application Form. The minimum additional investment into the Fund is \$5.000.

Distributions

An investor's share of any distributable income is calculated in accordance with the Constitution and is generally based on the number of units held by the investor at the end of the distribution period.

The Fund distributes income monthly. Although, Equity Trustees may change the distribution frequency at its discretion, it will not do so without first notifying investors. Distributions are calculated effective the last day of each distribution period and are normally paid to investors as soon as practicable after the distribution calculation date.

Investors in the Fund can indicate a preference to have their distribution:

- reinvested back into the Fund; or
- directly credited to their Australian dollar bank account.

Investors who do not indicate a preference will have their distributions automatically reinvested. Applications for reinvestment will be taken to be received immediately prior to the next Business Day after the relevant distribution period. There is no Buy Spread on distributions that are reinvested.

In some circumstances, the Constitution may allow for an investor's withdrawal proceeds to be taken to include a component of distributable income.

Indirect Investors should review their IDPS Guide for information on how and when they receive any income distribution.

Access to your money

Investors in the Fund can generally withdraw their investment by completing a written request to withdraw from the Fund and mailing it to:

The minimum withdrawal amount is \$5,000. Once we receive and accept your withdrawal request, we may act on your instruction without further enquiry if the instruction bears your account number or investor details and your (apparent) signature(s), or your authorised signatory's (apparent) signature(s).

Equity Trustees will generally allow an investor to access their investment within 7 days of acceptance of a withdrawal request by transferring the withdrawal proceeds to such investor's nominated Australian dollar bank account. However, Equity Trustees is allowed to reject withdrawal requests, and also to make payment up to 21 days after acceptance of a request (which may be extended in certain circumstances) as outlined in the Constitution and Reference Guide.

We reserve the right to accept or reject withdrawal requests in whole or in part at our discretion.

The price at which units are withdrawn is determined in accordance with the Constitution ("Withdrawal Price"). The Withdrawal Price on a Business Day is, in general terms, equal to the NAV of the Class, divided by the number of units on issue and adjusted for transaction costs ("Sell Spread"). At the date of this PDS, the Sell Spread is 0.10%.

The Withdrawal Price will vary as the market value of assets in the Class rises or falls.

Equity Trustees reserves the right to fully redeem your investment if your investment balance in the Class falls below \$400,000 as a result of processing your withdrawal request. In certain circumstances, for example, when there is a freeze on withdrawals, where accepting a withdrawal is not in the best interests of investors in the Fund including due to one or more circumstances outside its control or where the Fund is not liquid (as defined in the Corporations Act), Equity Trustees can deny or suspend a withdrawal request and you may not be able to withdraw your funds in the usual processing times or at all. When the Fund is not liquid, an investor can only withdraw when Equity Trustees makes a withdrawal offer to investors in accordance with the Corporations Act. Equity Trustees is not obliged to make such offers.

If you are an Indirect Investor, you need to provide your withdrawal request directly to your IDPS Operator. The time to process a withdrawal request will depend on the particular IDPS Operator and the terms of the IDPS.

Unit pricing discretions policy

Equity Trustees has developed a formal written policy in relation to the guidelines and relevant factors taken into account when exercising any discretion in calculating unit prices (including determining the value of the assets and liabilities). A copy of the policy and, where applicable and to the extent required, any other relevant documents in relation to the policy will be made available free of charge on request.

Additional information

If and when the Fund has 100 or more direct investors, it will be classified by the Corporations Act as a 'disclosing entity'. As a disclosing entity, the Fund will be subject to regular reporting and disclosure obligations. Investors would then have a right to obtain a copy, free of charge, of any of the following documents:

- the most recent annual financial report lodged with ASIC ("Annual Report");
- any subsequent half yearly financial report lodged with ASIC after the lodgement of the Annual Report; and
- any continuous disclosure notices lodged with ASIC after the Annual Report but before the date of this PDS.

Equity Trustees will comply with any continuous disclosure obligation by lodging documents with ASIC as and when required.

3. Benefits of investing in the Neuberger Berman Strategic Income Fund - I Class

An investment in the Fund provides diversified exposure to global fixed income investments and, more uniquely, access to the investment expertise and extensive industry experience of Neuberger Berman's broad, global fixed income platform comprising over 170 fixed income professionals employed across a number of specialist teams. Currently, the Fund obtains its exposure by investing all its assets in the Neuberger Berman Strategic Income Fund ("Underlying Fund"), which is a sub-fund of Neuberger Berman Investment Funds plc, an investment company with variable capital constituted as an umbrella fund with segregated liability between sub-funds under the laws of Ireland and authorised by the Central Bank of Ireland pursuant to the European Communities (Undertaking for Collective Investment in Transferable Securities) Regulations 2011, as amended) ("NBIF UCITS").

The investment strategy for the Fund is to invest in and actively manage, or gain exposure to, a multi-sector fixed income portfolio comprising multiple underlying strategies from across Neuberger Berman's fixed income platform and which is implemented by Neuberger Berman's multi-sector fixed income team ("Investment

The Investment Team's investment philosophy encompasses several key ideas, including:

- At the individual strategy level, a consistent philosophy across Neuberger Berman's fixed income platform is an emphasis on security selection as the key driver of excess returns over time.
- Multi-sector fixed income portfolios are best constructed using a broad range of underlying strategies, which helps provide diversification and portfolio correlation benefits.
- Asset allocation should focus on capital preservation and risk management of potential events with significant impact, but low probability of occurrence.
- Portfolio construction should involve no permanent biases to particular asset classes, but instead recognize that the optimal portfolio to achieve investor objectives changes over time.
- Market mispricings do occur and create opportunities to be taken advantage of by tactically adjusting the portfolio's allocation to the underlying strategies.

Finally, the Investment Team believes that the disciplined valuation approach based on unique insights and conviction which is employed across the Neuberger Berman fixed income platform generates added value and, with consistency, leads to the opportunity for attractive long-term returns.

4. Risks of managed investment

All investments carry risks. Different investment strategies may carry different levels of risk, depending on the assets acquired under the strategy. Assets with the highest long-term returns may also carry the highest level of short-term risk. The significant risks below should be considered in light of your risk profile when deciding whether to invest in the Fund. Your risk profile will vary depending on a range of factors, including your age, the investment time frame (how long you wish to invest for), your other investments or assets and your risk tolerance.

The Responsible Entity and Investment Manager do not guarantee the liquidity of the Fund's investments, repayment of capital or any rate of return or the Fund's investment performance. The value of the Fund's investments will vary. Returns are not guaranteed, and you may lose money by investing in the Fund. The level of returns will vary and future returns may differ from past returns. Laws affecting managed investment schemes may change in the future. The structure and administration of the Fund is also subject to change.

In addition, we do not offer advice that takes into account your personal financial situation, including advice about whether the Fund is suitable for your circumstances. If you require personal financial or taxation advice, you should contact a licensed financial adviser and/or taxation adviser.

Market risk

The market price of investments owned by the Fund may go up or down, sometimes rapidly or unpredictably. Investments may decline in value due to factors affecting investment markets generally or particular industries represented in the investment markets. The value of an investment may decline due to general market conditions which are not specifically related to a particular company, such as real or perceived adverse economic conditions, supply and demand for particular securities or instruments, changes in the general outlook for corporate earnings, changes in interest or currency rates or adverse investor sentiment generally. They may also decline due to factors which affect a particular industry or industries, such as labour shortages or increased production costs and competitive conditions within an industry. During a general market downturn, multiple asset classes may decline in value simultaneously.

Further, changes in tax, legal and economic policy, political events and technology failure can all directly or indirectly create an environment that may influence the value of your investments, including your investment in the Fund.

International investing risk

The Fund will hold investments in global debt securities. Certain countries may impose restrictions on the ability of locally domiciled companies to make payments of principal, dividends or interest to investors located outside the country, due to blockage of foreign currency exchanges or otherwise. Generally, there may be less publicly available information about foreign companies due to less rigorous disclosure or accounting standards and regulatory practices. In addition, the Fund could be subject to risks associated with adverse political and economic developments in certain countries, which could cause the Fund to lose money on these investments.

Emerging markets risk

Emerging markets are markets in certain countries which may not be as developed, efficient or liquid as Australian markets. Therefore, the value of securities in these markets may often be more volatile. Emerging markets risk is also caused by exposure to economic structures that are less diverse and mature, and to political systems that are less stable, than those of developed countries. In addition, issuers in emerging markets may experience a greater degree of change in earnings and business prospects than would companies in developed markets.

Regulatory risk

This is the risk that domestic or international laws or regulations are changed adversely or that regulatory supervision of transactions and reporting is performed by the Investment Manager at less than an appropriate standard. The Investment Manager aims to manage this risk by regularly and closely reviewing changes in the regulatory environment.

Currency risk

The Fund will invest in securities denominated in currencies other than Australian dollars. If these currencies change in value relative to the Australian dollar, the value of the investment can change.

Inflation risk is the risk that returns will not be sufficiently higher than inflation to enable an investor to meet their financial goals.

Credit risk

The issuer or party to a transaction may not repay the principal, make interest payments or fulfil other financial obligations in full and/or on

The market value of an investment can also fall significantly when the perceived risk of a debt security increases or its credit rating declines, and can negatively impact on the performance of the Fund.

The risk that the investment value or future returns of an asset may be adversely impacted by changes in interest rates. The value of fixed rate securities (such as bonds) in which the Fund may invest generally will have an inverse relationship with interest rates. For example, the value of a bond may fall when interest rates rise, and vice versa. Generally, the longer the maturity of the bond, the greater its sensitivity to changes in interest rates (i.e. duration) and the greater the impact that changes in interest rates will have on the value of the bond

Fixed income securities risk

Fixed income securities are subject to the risk of an issuer's ability to meet principal and interest payments on the obligation (credit risk), and may also be subject to price volatility due to factors such as interest rate sensitivity, market perception of the creditworthiness of the issuer and general market liquidity (market risk). In addition, the Investment Manager may invest the Fund in fixed income securities which are interest rate sensitive. An increase in interest rates will generally reduce the value of fixed income securities, while a decline in interest rates will generally increase the value of fixed income securities. The performance of the Fund will therefore depend in part on the ability to anticipate and respond to such fluctuations in market interest rates, and to utilise appropriate strategies to maximise returns, while attempting to minimise the associated risks to investment capital. Fixed income securities are also exposed to the risk that their or their issuers' credit ratings may be downgraded, which can cause a significant drop in the value of such securities. In the event of such downgrading, the value of the Fund may be adversely affected. The Investment Manager may or may not be able to dispose of the fixed income securities that are being downgraded.

High yield securities risk

In respect of lower rated or unrated (i.e. below investment grade or high yield) securities, such securities are more likely to react to developments affecting market and credit risk than more highly rated securities, which primarily react to movements in the general level of interest rates. Investors should carefully consider the relative risks of investing in high yield securities and understand that such securities generally are not meant for short-term investing.

The risk of loss due to default by these issuers is significantly greater because lower rated and unrated securities of comparable quality generally are unsecured and frequently are subordinated to the prior payment of senior indebtedness. In addition, investors in such securities may find it more difficult to sell high yield securities or may be able to sell the securities only at prices lower than if such securities were widely traded.

Security selection risk

The Investment Manager may make investment decisions that result in low returns. This risk is mitigated to some extent by the knowledge and experience of the Investment Manager.

Liquidity risk

There may be times when there may be a limited secondary market for the securities in which the Fund may invest and that may affect the ability of the Fund to realise investments or to meet withdrawal requests (for example, in a falling market where debt securities may become less liquid). The Investment Manager and the Responsible Entity attempt to mitigate the liquidity risk factor by generally investing in securities that are believed to offer sufficient liquidity.

Fund risk

Risks particular to the Fund include that it could terminate, the fees and expenses could change, the Investment Manager or Responsible Entity could be replaced and the investment professionals could change. There is also a risk that investing in the Fund may give different results than investing directly in the underlying assets of the Fund themselves because of income or capital gains accrued in the Fund and the consequences of investment and withdrawal by other investors.

Pandemic and other unforeseen event risk

Health crises, such as pandemic and epidemic diseases, as well as other catastrophes that interrupt the expected course of events, such as natural disasters, war or civil disturbance, acts of terrorism, power outages and other unforeseeable and external events, and the public response to or fear of such diseases or events, have and may in the future have an adverse effect on the economies and financial markets either in specific countries or worldwide and consequently on the value of the Fund's investments. Further, under such circumstances the operations, including functions such as trading and valuation, of the Investment Manager and other service providers could be reduced, delayed, suspended or otherwise disrupted.

5. How we invest your money

Warning: When choosing to invest in the Fund, you should consider the likely investment returns, the risks of investing and your investment time frame.

Investment objective

The Fund aims to maximize total return from high current income and long-term capital appreciation by opportunistically investing in a diversified mix of fixed rate and floating rate debt securities under varying market environments.

Benchmark

Bloomberg U.S. Aggregate Bond Index (AUD Hedged Total Return) Investors should note that the Investment Manager does not intend for the Fund to track the Benchmark, which is included for performance comparison purposes only.

Minimum suggested time frame

The minimum suggested investment time frame for the Fund is 5

Risk level

Medium.

There is medium level risk of loss of investment over one year. An investment in the Fund has the potential to produce medium level returns over the minimum suggested timeframe.

Investor suitability

The Fund is designed for investors seeking high current income via exposure to global fixed income markets and who understand and accept that the Fund is expected to experience medium to high levels of volatility.

Investment style and approach

The Investment Team's investment style can be defined as relative value with an emphasis on applying active management to seek to maximise risk-adjusted returns. A relative value investment style involves fundamentally analysing the value of a particular debt security by assigning an internal credit rating to that security and then using that rating to compare the security's value to other analysed securities in the same industry and similarly rated securities across other industries.

The Investment Team's approach in constructing a multi-sector fixed income portfolio for the Fund involves 2 key components: (1) selecting from among the various high performing strategies across Neuberger Berman's fixed income platform, each of which is managed by a sector specialty team implementing a disciplined investment process with a focus on security selection and an emphasis on downside protection; and (2) both strategically and tactically allocating among the selected underlying strategies in order to achieve the Fund's objective. This may be achieved through investing directly in those strategies, or by gaining exposure to them through another Neuberger Berman fund (or funds).

By constructing a portfolio built on a foundation of strong performance from the underlying strategies coupled with a principal-protection oriented asset allocation strategy, the Investment Team aims to achieve the objectives of maximising total return and diversification, and maintaining a level of capital preservation for investors.

Under normal market conditions, the Investment Team seeks to maintain the average credit rating of the portfolio, based on the weighted average credit quality of the underlying securities, at investment grade. Credit quality ratings are obtained from Barclays, which bases its ratings on the conservative average of Moody's, S&P's and Fitch's ratings.

Investment guidelines and restrictions

The Fund is authorised to invest in:

- (a) debt securities, including:
- fixed and floating rate debt securities, including bonds issued by U.S. and non-U.S. governments, government agencies and
- (ii) corporate bonds, debentures and notes (including freely transferable and unleveraged structured notes, contingent convertible bonds and freely transferable promissory notes);
- (iii) privately issued asset-backed securities, structured securities (including mortgage-backed securities such as pass-through certificates, collateralised mortgage obligations and interest and principal only components of mortgage-backed securities and collateralised loan obligations with respect to mezzanine floating rate debt) that derive interest and principal payments from specified assets (such as residential and commercial mortgages, credit card debt and pools of other types of receivables such as loans);

- (iv) payment-in-kind bonds (which are bonds that pay interest in the form of additional bonds of the same kind), participation interests in loans (and which are securitised and freely transferable):
- (v) deferred payment securities (securities which pay regular interest after a predetermined date) and zero coupon securities; and
- (vi) debt securities of the types described above issued by issuers in emerging market countries;
- (b) collective investment schemes, investment companies, unit trusts and other types of funds, including the Underlying Fund, a sub-fund of NBIF UCITS;
- (c) participatory notes;
- (d) derivative instruments, including: swaps (which may include foreign exchange, interest rate, credit default and total return swaps); futures; and forwards;
- (e) spot foreign exchange contracts; and
- (f) money market instruments, including bank deposits, fixed or floating rate instruments (including commercial paper), floating or variable rate notes, bankers acceptances, certificates of deposit, debentures and short-dated government or corporate bonds, cash and cash equivalents (including treasury bills), that are rated as investment grade by a recognised rating agency.

Currently, the Fund obtains its exposure by investing all its assets in the Underlying Fund. In the event that the Fund invests directly (other than via the Underlying Fund), the Investment Manager will endeavour to meet the following investment guidelines and restrictions in investing and managing the Fund:

- (a) The Fund will invest primarily in debt securities issued by U.S. corporations or by the U.S. government and its agencies. Such securities will be listed, dealt or traded on recognised markets and may be rated investment grade or below investment grade by recognised rating agencies, or non-rated.
- (b) Although the Fund's investments will be concentrated in the U.S., the Fund may also invest in debt securities issued by non-U.S. governments and their agencies and corporations located globally up to one third of its NAV. This may include investing in debt securities issued by companies located in, and governments and government agencies of, emerging market countries.
- (c) The Fund may invest up to 10% of its NAV in securities which are issued or guaranteed by a single sovereign issuer and which are below investment grade.
- (d) Although the maximum proportion of the Fund's NAV that can be subject to total return swaps is 20%, the expected proportion is 0%.
- (e) The Fund will not utilise securities lending, repurchase and reverse repurchase agreements or margin lending.

Although there are no constraints on the Fund's investments in terms of credit rating or country exposure, it is the intention of the Investment Manager to create a well-diversified portfolio.

Derivatives may be used for hedging purposes, efficient portfolio management and/or investment purposes.

Asset allocation

The Fund invests substantially all its assets in the Underlying Fund, which generally adheres to the following asset allocation ranges:

Debt securities: 80 - 100%

Cash: 0 - 20%

Changing the investment strategy

The investment strategy and asset allocation parameters may be changed. If a change is to be made, investors in the Fund will be notified in accordance with the Corporations Act.

 - holds an Australian financial services licence authorising it to provide custodial or depository services under the Corporations Act 2001; or
 - ii. is exempt under the Corporations Act 2001 from the requirement to hold such a licence; and
- d) either:
 - i. satisfies one of the 'geographical link' tests in subsection 6(6) of the AML/CTF Act; or
 - ii. has certified in writing to the relevant reporting entity that its name and enrolment details are entered on the Reporting Entities Roll; and
- e) has certified in writing to the relevant reporting entity that it has carried out all applicable customer identification procedures and ongoing customer due diligence requirements in accordance with Chapter 15 of the AML/CTF Rules in relation to its underlying customers prior to, or at the time of, becoming a customer of the reporting entity.
