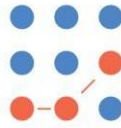

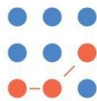

Prior to joining the ICD, Rahul was a corporate lawyer at a leading Canadian law firm, and later, President and CEO of the Toronto Foundation. He was also Vice President of the Toronto 2008 Olympic Bid and, as part of the Mayor's Blue Ribbon Fiscal review panel in 2008, Rahul was involved in identifying efficiencies for the City of Toronto. In 2012, his commitment to city building was recognized as he received the Queen Elizabeth II Diamond Jubilee Medal. Toronto Life magazine named him one of "The Most Influential" people in the city, and he was named to the Quadrangle Society at Massey College.
