



About the Exam

Often, with exams, the fear of the unknown affects learners most. It's vital that you know what to expect on exam day. Going in blind is only going to make your anxieties worse. Here's everything you need to know.

The CC exam contains 100 multiple-choice items across five domains or topics. The graphic below shows a full list of the domains and how they are weighted.



For a more in-depth look at what each domain entails, more information is available in the **exam outline**. The CC exam and exam outlines are available in **English**, **Chinese**, **Japanese**, **Spanish**, and **German**.

You will have 2 hours to complete the exam and must score a minimum 700/1000 points to pass. Exams are only held in-person at Pearson VUE testing centers.



Your Exam Day Checklist


Both leading up to and on the day of your exam, there are several things you'll need to do. Review the information below to ensure you're completely prepared.

Request Special Accommodations

ISC2 is committed to ensuring our exams are accessible to everyone. If you need special accommodations, it's important to let us know as early as possible. You'll also need to take a slightly different approach to scheduling your exam.

To request accommodations, you must complete the **Exam Accommodation Request Form** and email it to <u>examadministration@isc2.org</u> before registering for your exam. You'll need to explain the examination accommodation you require, provide documentation supporting them, and specify the exam you want to take and the testing location.

Exam accommodations are individualized and considered on a case-by-case basis. Once ISC2 approves them, we'll send them to Pearson VUE Accommodations. Please allow two to three business days for Pearson VUE to get this information. Then, call Pearson VUE at +1.800.466.0450 and schedule your exam. Note: Please reach out to ISC2 first; do not start by scheduling through Pearson VUE's website or their main registration phone line.



Ensure You Have the Proper Identification

You must provide two forms of identification at the testing center to take the CC exam. Both IDs must be valid (not expired) original documents (not photocopies or faxes). Your primary identification must include your photo and signature, and your photo must be permanently affixed to the document. Your secondary identification must include your signature. If either document lacks a signature, it must be a legal, official form of identification approved by local government. Of the following are acceptable forms of primary identification:

- Government issued driver's license or identification card
- U.S. state-issued driver's license
- U.S. state-issued driver's learner's permit (card only with photo and signature)
- National/state/country Identification card
- Passport
- Military ID
- Military ID for spouses and dependents
- Alien registration card (green card; permanent resident visa)
- Government issued local language ID (plastic card with photo and signature)
- Employee ID
- School ID
- Credit card (only if it contains both your photo and a signature)

The following are acceptable forms of secondary identification:

- U.S. Social Security card
- Debit/ATM card
- Credit card (providing that your signature is on it, and it isn't expired)
- Any form of ID on the primary ID list

Check that Your Names Match

Ahead of your exam, you must ensure that the first and last name on your ID **exactly match** the first and last name that you used to register with Pearson VUE. (For example, if your driver's license shows your name as Charles, be sure to register as Charles — not as Chuck or Charlie.)

We'll email you prior to your exam asking you to **log in and verify** that the name on your exam registration exactly matches with your two forms of ID. If the name displayed is different, please update your name in the form and resubmit. Name changes cannot be made on exam days, including at the testing center.

If your names don't match, you'll be asked to leave and you'll forfeit your testing fee. If you have recently had a legal name change, you'll need to bring proof to the test center on exam day. Your document must be an original (not a photocopy or fax). Pearson VUE will only accept marriage licenses, divorce decrees, or court-sanctioned legal name change documents.

Reschedule or Cancel Your Exam

If you need to reschedule or cancel your exam, contact Pearson VUE. You can either do this **online** within 48 hours of your appointment, or over the **phone** at least 24 hours prior to your exam. Once your initial exam is scheduled, you may only reschedule within 365 days of your initial exam date. You must sit for your exam within 365 days of your initial exam date, or your exam fee will not be refunded.

Check In

On the day of your exam, you must arrive at least 30 minutes before your start time to complete the check-in process. To check in, you'll need to:

- Show two acceptable forms of ID
- Provide your signature
- Submit to a palm vein scan (unless it is prohibited by law). If you are not comfortable with this form of identification, please contact examadministration@isc2.org prior to booking your exam.
- Have your photo taken. Hats, scarves and coats may not be worn for your photo. You also can't wear these items in the test room.
- Leave your personal belongings outside the testing room. You'll have access to secure storage, however, space is limited. Pearson VUE test centers do not assume responsibility for your personal belongings.

The Test Administrator (TA) will give you a short orientation before escorting you to a computer terminal. Once you are seated at your desk and the TA has started your test, review and accept the Non-Disclosure Agreement (NDA) within five minutes. If you do not review and accept the NDA within the allotted time, you cannot take the exam and your exam fee will not be refunded. You may review the NDA before your exam day **here**.

Managing Exam Anxiety

Now that we've covered the logistics, we can consider how you're feeling. Hopefully, the above information has calmed your nerves by giving you a better idea of how the CC exam works, what you need to do in the lead-up, and what will happen on the day, but it's normal to still feel a bit anxious.

Looking after your mental health is always important, especially in the lead-up to the CC or any other exam. Not only are you under a lot of strain, but poor mental health can impact your exam results. So, here are four tips for managing exam anxiety.

Practice Mindfulness

Mindfulness is a particularly useful method for managing exam stress. Consider incorporating practices such as deep breathing, meditation, or progressive muscle relaxation into your study routine. These techniques can help you focus before a study session, wind down once you're done studying, or calm down when you're feeling overwhelmed.

Reward Yourself

While it's important to be healthy during your study period, cutting out treats entirely will only make you miserable. Eat healthy meals, but reward yourself occasionally with ice cream, chocolate or whatever treats you enjoy. The dopamine hit you get when you eat something you like can do wonders for your mental health.

Talk to People

Our worries and concerns often seem so much larger in our heads. That's not to invalidate how you're feeling, but it is true that talking about our anxieties usually goes a long way toward easing them. Whether you talk to your family and friends or connect with your peers through an **ISC2 forum** or **local chapter**, talking helps. Don't suffer in silence – even if you're not offered a solution, it helps to have someone listen.



Prepare Yourself

To avoid unnecessary stress, it's crucial to ensure you're fully prepared for the day of your exam. Map your route to the test center and do a practice run a few days before your exam. Double-check your route a few hours early to account for traffic or public transit delays and try to get to your test center reasonably early.

Lay out everything you need to take with you the night before your exam – including your clothes and ID – get a good night's rest and eat a healthy and hearty meal. Review the information above so you know what to expect.

able to communicate and partner with clients is critical. You have to be able to take technical concepts and break them down into layman's terms, as the people you work with aren't always engineers. If you don't have a foundational understanding of the technology and processes required to keep your customers' environments secure, you won't be able to break it down into easier-to-digest pieces."

After earning her CC Certification, Janet became an ISC2 member and has since been enjoying all the membership benefits. Janet has found ISC2's Skill Builder series helpful in advancing her career. "They are short-form trainings that you can do on your phone that both contribute to your overall learning but also count towards the learning credits needed to maintain your certification.
