# Data privacy: Iron Mountain InSight Digital Experience Platform (DXP)

### Service overview

Customers can use the platform to access, manage, govern, and monetize physical and digital information. Through Iron Mountain InSight® Digital Experience Platform (DXP)'s unique intelligent document processing that extracts, classifies, and enriches information with speed and accuracy, customers can quickly turn physical and digital unstructured information into structured, actionable data they can use in their integrated business applications and as the basis for their Al initiatives. The modular InSight DXP platform includes secure generative Al-powered chat, enabling fast access to data trapped within documents. It can be used to quickly query data and documents in a secure isolated environment separate from publicly available generative Al applications.



## **Customer data**

Any type of customer data (including confidential and personal data) may reside on the InSight DXP platform and the customer has full discretion as to what data is submitted to the platform for processing. Customer data is retained only for the duration of the services and then either returned or deleted upon the customer's direction.

## **Sub-processors**

Certain functionalities of the Insight DXP platform are enabled by selected third



party providers who are subject to robust data processing measures and controls. Support services are provided by Iron Mountain's global team with team members in each region as well as by selected third party providers who are subject to the same policies and standards as Iron Mountain employees.

## International data transfers

Many countries have laws governing international transfers of personal data. Iron Mountain is aware of these requirements and relies on the Standard Contractual Clauses for internal and external transfers of personal data, as may be applicable and relevant, e.g. EU/UK personal data to countries such as the U.S. and India. Iron Mountain is committed to comply with the EU-U.S., the UK Extension to the EU-U.S. and the Swiss-U.S. Data Privacy Framework.

Iron Mountain has a Global Privacy Program and an appointed Global Privacy Officer. A team of privacy & compliance professionals monitor legislative and regulatory developments and provide advice to ensure that relevant privacy safeguards are embedded into our services.
