## Business challenge

## Impact

Most organisations are subject to multiple data security and privacy regulations, and noncompliance costs average more than \$14 million.<sup>1</sup> But the cost of achieving compliance isn't trivial. The labour intensity of

document and data management accounts for 94%<sup>2</sup> of annual compliance maintenance costs, which can add up to \$31 million.<sup>3</sup>

Leading enterprises view digital transformation as an imperative,<sup>4</sup> using technology to extract insights from data that can improve decision-making and provide better customer experience. However, when information is stored on paper, it's hard to find and can't be easily accessed or shared. Information silos and the resulting information management inefficiencies impede the ability to effectively connect and use data.
