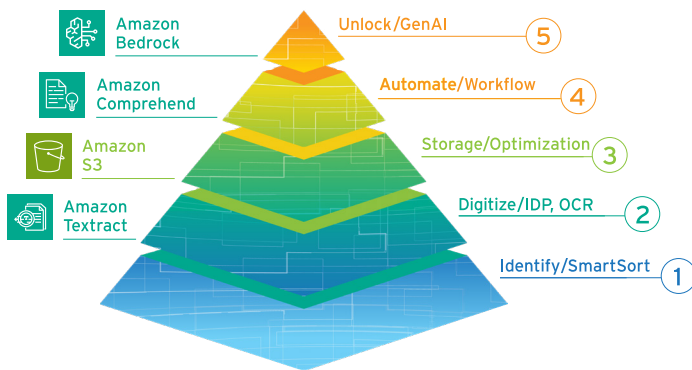

AI tools like Textract, Comprehend, and Rekognition classify content and extract key metadata, while Retrieval-Augmented Generation (RAG) brings deeper insight into documents. The latest release introduces agentic AI, task-specific agents that answer natural-language questions, surface sensitive content like PII across languages, and summarize large volumes of data instantly.
