HOME ENERGY ACCELERATOR PROGRAM

Organization: City of Edmonton

Organization Category: Municipal Government

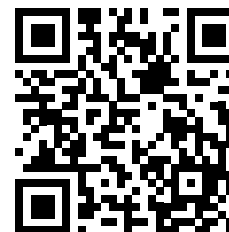
Program Type: Advice, Awareness/Information, Financial Incentive, Rebate, Retrofit

Eligibility: Replace a window in a preexisting rough opening with an ENERGY STAR® certified, triple pane window.

Amount: \$50 per rough opening

Edmonton's Home Energy Retrofit Accelerator is a program that helps you understand your home's energy efficiency and provides rebates for upgrades. Insulation, windows, water and space heating equipment are all eligible for rebates with bonuses available for bigger renovations.

TOWN OF BANFF DEEP RETROFIT PROGRAM

Organization: Town of Banff

Organization Category: Municipal Government

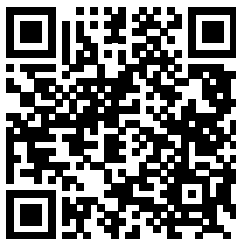
Program Type: Rebate, Retrofit

Eligibility: Varies, see program details.

Amount: Varies, see program details.

The Deep Retrofit Program incentivizes energy savings independent of the type of upgrade. Instead of receiving a rebate on specific upgrades or purchases, the rebate amount depends only on the calculated annual energy savings of the project (in gigajoules; GJ). This approach acknowledges that buildings throughout the community can be very different and will allow residents to choose the most cost-effective ways of improving the energy efficiency of their specific home.

TOWN OF BANFF POST-PURCHASE REBATE PROGRAM

Organization Category: Municipal Government

Program Type: ENERGY STAR®, Rebate, Retrofit

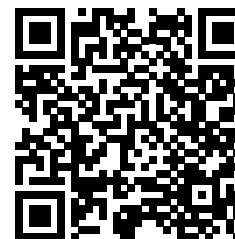
Eligibility: Post-purchase rebates are available to Banff residents with proof of residency.

Amount: See table.

The Town of Banff provides post-purchase rebates to help residents and local businesses save money while improving energy and water efficiency or adopting active transportation. Eligible products include e-bikes, appliances, toilets, windows, rain barrels, and more.

Window Replacement	ENERGY STAR® certified or U-value < 1.4	\$100/window
High Efficiency Window	ENERGY STAR® Most Efficient or U-value < 1.0	\$200/window

ENERGY SAVINGS PROGRAM WINDOW AND DOOR REBATES

Organization: cleanBC

Organization Category: Provincial Government

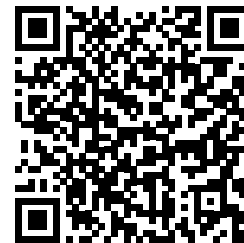
Program Type: Rebate, Retrofit

Eligibility: B.C. citizens who live in an eligible home, meet income qualification requirements, and have residential utility accounts with BC Hydro, FortisBC, or municipal utility.

Amount: Up to \$9,500

Window and door upgrades can help maintain even temperatures throughout your home, reduce unwanted outdoor noise, and reduce heat loss during the cold winter months. As part of the CleanBC Better Homes Energy Savings Program, you can receive a rebate of up to \$9,500 with a maximum of \$950 per window or door when replacing your current windows or exterior doors with program qualified products.

HOME RENOVATION REBATE

Organization: BC Hydro - Residential Customers

Organization Category: Utility Company

Program Type: Financial Incentive, Rebate, Retrofit

Eligibility: The Home Renovation Rebate Program is intended for homes that are primarily heated by electricity (electric baseboards, electric furnaces) and have high bills from space heating.

Amount: Up to \$2,000

In partnership with CleanBC, the Home Renovation Rebate Program offers several energy-savings rebates for homes in B.C. This program offers homeowners a wide variety of incentives to help reduce ongoing energy costs. Rebates are provided for upgrades, including windows and doors, insulation, heat pumps, and heat pump water heaters.

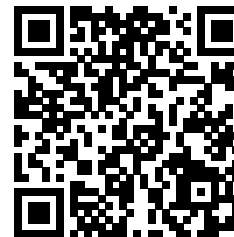

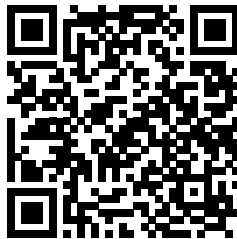
Eligibility: Must upgrade to eligible ENERGY STAR® certified triple pane windows and/or doors

TOTAL HOME ENERGY SAVINGS PROGRAM

Organization: NB Power

Organization Category: Utility Company

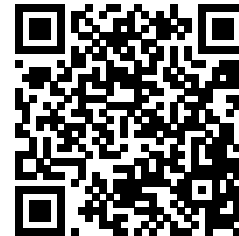
Program Type: Advice, ENERGY STAR®, Rebate, Retrofit

Eligibility: Windows, doors must be certified ENERGY STAR® Version 5.0

Amount: \$50 per rough opening

This Program offers money back on efficiency upgrades on everything from insulation and air-sealing to high efficiency central heating systems to windows, doors, and more (including ENERGY STAR® certified products). A certified energy advisor will evaluate the home to find out where it needs upgrades and will give customized recommendations to improve space and water heating energy efficiency.

NEWFOUNDLAND AND LABRADOR

PROVINCIAL HOME REPAIR PROGRAM (PHRP)

Organization: Newfoundland and Labrador Housing Corporation (NLHC)

Organization Category: Provincial Government

Program Type: Forgivable/Repayable Loan Funding, Retrofit

Eligibility: Homeowners with low income (an annual household income of \$42,500 or less; \$65,000 in Labrador) requiring repairs to their dwellings.

Amount: Up to a maximum of \$5,000 (\$6,500 in Labrador)

Through Newfoundland and Labrador Housing Corporation (NLHC), PHRP is designed to provide funding to make repairs necessary to maintain a dwelling for continuous safe occupancy. This may include: heating, electrical or plumbing systems, deteriorated structures, foundations, windows, doors, roofing or siding.

HOME ENERGY ASSESSMENT

Organization: Efficiency Nova Scotia

Organization Category: Provincial Government

Program Type: Rebate, Retrofit

Eligibility: Available for homes in Nova Scotia that are at least six months old and have not yet started renovations.

Amount: Up to \$5,000

This Program offers rebates on cost-effective energy saving upgrades for eligible properties. An energy audit will identify energy saving upgrades (which may include improvements to lighting, heating, water heating, window and door replacement, insulation and more) and determine your rebates.

HOME RENOVATION SAVINGS PROGRAM

Organization: Save on Energy.

Organization Category: Provincial Government

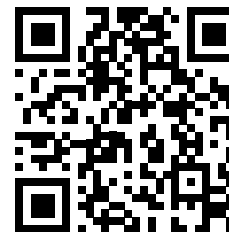
Program Type: ENERGY STAR®, Rebate, Retrofit

Eligibility: An initial home energy assessment is required before beginning any work.

Amount: \$100 per rough opening

Enbridge Gas and Save on Energy, with support from the Ontario Government, have partnered to launch the new Home Renovation Savings™ program to help Ontarians improve home energy efficiency and comfort.

PRINCE EDWARD ISLAND

BUILDING ENVELOPE UPGRADE REBATE

Organization: Efficiency PEI

Organization Category: Provincial Government

Program Type: ENERGY STAR®, Financial Incentive, Rebate, Retrofit

Eligibility: Must have an energy audit conducted by approved energy partners, see program details.

Amount: \$125 per window/door opening to a maximum of \$1000/property
efficiencyPEI offers grants for the installation of insulation, air sealing improvements as well as ENERGY STAR® windows and doors. Upgrades to the shell of a house (known as a building envelope) protects it from the elements and can yield big savings on heating costs. Upgrades will also make your home more comfortable and environmentally friendly. As of June 2, 2025, residential rental property owners (landlords) can also apply for rebates through this program.

In addition to rebates, financing is available through the Government of Prince Edward Island to assist with the up-front costs of insulation upgrades.

QUÉBEC

RÉNOCLIMAT PROGRAM

Organization: Rénoclimat

Organization Category: Provincial Government

Program Type: ENERGY STAR®, Grant, Retrofit

Eligibility: To participate in the Rénoclimat program, you must be the legal owner of an eligible dwelling or an authorized representative acting on behalf of co-owners.

Amount: \$150 per rough opening

The Rénoclimat program, available in Québec, helps homeowners improve their home's energy performance through guided renovations and financial assistance. Participants start with an energy evaluation to identify air leaks and inefficiencies, followed by a personalized list of recommended upgrades. Homeowners can consult with an energy efficiency advisor and receive rebates for eligible retrofits, such as insulation improvements, air sealing, and heating system upgrades.

By participating, you can lower energy consumption, reduce heating costs, and increase comfort and home value. If you notice high heating bills, cold drafts, or issues like mold and icicles, Rénoclimat may be the right solution for your home.

Organization: Government of Yukon, Energy, Mines and Resources

Organization Category: Provincial Government

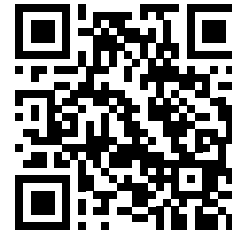
Program Type: ENERGY STAR®, Rebate

Eligibility: Windows must be ENERGY STAR® certified and be installed in a heated building that is at least five years old.

Amount: \$120 per window to a maximum rebate of \$1,800 per home or building.

The Government of Yukon offers this rebate for upgrading to ENERGY STAR® certified windows, in heated building that are at least five years old.
