

Health Care Service Sector Update

December 2012

Summary

- The S&P Health Care Services Index has declined 3.8% over the last three months, underperforming the S&P 500.
- Over the last three months:
 - > The best performing sectors were Contract Research Organizations (up 19.5%) and Acute Care Hospitals (up 11.1%).
 - > The worst performing sectors were Diagnostic Imaging (down 11.8%) and Emergency Services (down 10.7%).

- The current median LTM revenue and LTM EBITDA multiples for the Health Care Services industry overall are 1.2x and 8.3x, respectively.
- The sectors with the highest valuation multiples include:
 - > Specialty HCIT (2.2x LTM Revenue, 16.6x LTM EBITDA)
 - Assisted Living (1.8x LTM Revenue, 13.1x LTM EBITDA)

M&A Activity - Health Care Services

M&A Overview

The last twelve months ("LTM") M&A volume in the Health Care Services sector has shown a monthly decline since February 2012. The deal volume has declined by 29.1% Y-o-Y to 387 deals. Over the last three months, deal volume has declined by 27.5% Y-o-Y to 87 deals for the three months ended November 2012.

Exhibit 1: Transaction Activity





Exhibit 2: Rolling LTM - Transaction Volume



M&A Activity by Health Care Services Sector

Acquisitions were announced across a wide range of subsectors, including Homecare / Hospice / Long-term Care / Assisted Living Care, Care Management / TPA, Specialty, and Clinical Laboratories, collectively representing 41% of activity by number of deals.

Notable Transactions in the Last Three Months

SPSmedical Supply Corp.

On November 2, SPSmedical Supply Corp. was acquired by Cantel Medical Corp (NYSE: CMN) through its subsidiary Crosstex International, Inc. for approximately \$36 million in cash, representing a 2.1x and 8.4x revenue and EBITDA multiple, respectively. SPSmedical is the leading manufacturer and provider of biological and chemical indicators for sterility assurance monitoring services in the acute-care, alternate-care and dental markets. SPSmedical approximately generated LTM revenue and adjusted EBITDA of \$18 million and \$4 million, respectively.

Nurse On Call, Inc.

On November 1, Emeritus Corporation (NYSE:ESC) announced it had acquired a 91% stake of Nurse On Call, Inc. for approximately \$102.5 million in cash. The remaining equity will be retained by the senior management of NOC's. Nurse On Call is the largest Medicare-licensed home health care provider in Florida and one of the largest providers in the United States, generating annually approximately \$140 million in revenues and \$17 million in EBITDA.

Spectrum Surgical Instruments Corp. / Total Repair Express, LLC

On October 16, Steris Corporation (NYSE: STE) acquired Spectrum Surgical Instruments Corp. from Richard Schultz and his wife for \$76 million. In a related transaction, Spectrum subsequently became the subsidiary acquisition vehicle in connection Steris' \$35 million acquisition of Total Repair Express, LLC. Spectrum Surgical Instruments Corp. provides surgical instrument care products, medical cleaning brushes, and surgical instrument accessories for hospitals, surgery centers, and veterinary centers in the U.S. Total Repair Express provides surgical instrument repair services and instrument care products. Steris financed the two transactions through an existing credit facility. Both companies will be integrated into Steris Corp.'s Specialty Services division, which provides chamber cleanings, space decontamination solutions, and instruments repair services. The strategic acquisitions were intended to help Steris enter into the surgical instrument repair and care business and strengthen its presence in hospital sterile processing and surgical departments.

Mediware Information Systems, Inc.

On September 11, Mediware Information Systems was acquired by Thoma Bravo for approximately \$190 million, representing approximately 2.4x and 11.4x revenue and EBITDA multiple, respectively. Thoma Bravo acquired all outstanding shares of Mediware for \$22 per share. Mediware designs, develops, markets, licenses, implements, and supports clinical and performance management information software systems used by hospitals, long-term and alternative care facilities, behavioral health facilities, and blood and blood plasma centers.
