Healthcare Services Sector Update

March 2019

Q Highlights

The **S&P Healthcare Services** Index declined 5.8% over the last month, as compared to the S&P 500, which increased 1.8% over the same period.


Over the past month:

The sectors experiencing the most growth were Hospital Vendors (up 10.1%), Behavioral Health (up 5.6%) and Contract Research Orgs (up 4.0%).

The sectors experiencing the most decline were Pharmacy Management (down 20.5%), Providers – Other (14.8%) and Specialty Managed Care (8.0%).

The current average LTM revenue and LTM EBITDA multiples for the Healthcare Services industry overall are 2.27x and 14.3x respectively.





Healthcare Services Sector Change


Average % - 1 Month Change

Healthcare Services Sector Change


Average % - 12 Month Change
