Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 1,341 tCO₂e by 2030. This is a reduction of 32.34%.

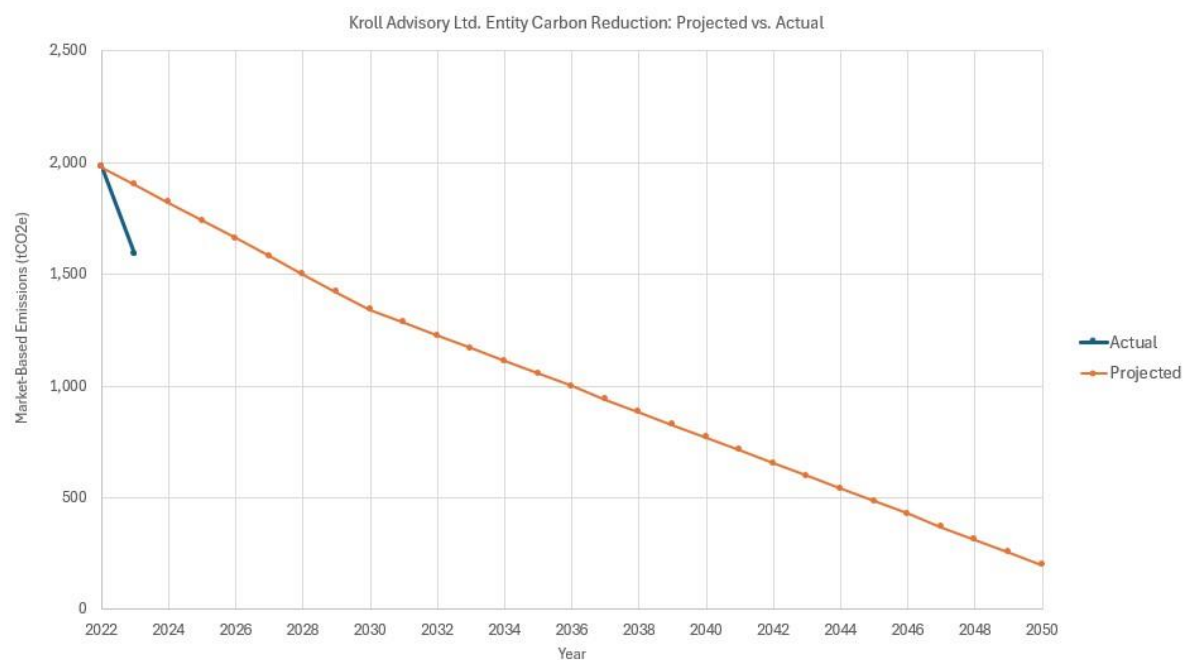
Kroll Advisory Ltd., commits to reduce Scope 1 and 2 emissions 70% by 2030 from a 2022 base year.

Kroll Advisory Ltd., commits to reduce a subset of Scope 3 emissions which includes 3.5, 3.6 and 3.7 25% by 2030 from a 2022 base year.

Kroll Advisory Ltd., commits to reduce Scope 1 and 2 emissions 90% by 2050 from a 2022 base year using permanent carbon removal for the remaining 10%.

Kroll Advisory Ltd., commits to reduce Scope 3 emissions 90% by 2050 from a 2022 base year using permanent carbon removal for the remaining 10%.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2022 baseline. The carbon emission reduction achieved by these schemes equate to 390 tCO₂e, a 19.68%ge reduction against the 2022 baseline and the measures will be in effect when performing the contract

Kroll Advisory Ltd., directly purchases clean power to abate Scope 2 GHG emissions, ISO 14001 certified, 77% of employees work in LEED (Leadership in Energy and Environmental Design) or BREEAM (Building Research Establishment Environmental Assessment Method) certified buildings, assess our sustainability performance through CDP and EcoVadis.

In the future we hope to implement further measures such as:

Initiative 1: Kroll clean power

Directly purchase clean power to abate scope 2 emissions;

Initiative 2: Supplier clean power

Target key tier 1 and 2 suppliers to implement clean power;

Initiative 3: Sustainable commute

Sustainable commute program, incentivize employees to transition to EVs, via non-financial or financial incentives;

Initiative 4: Travel policy

Implementation of a travel policy to reduce non-essential travel and encourage low carbon transport; and

Initiative 5: SAFc procurement

Purchase SAFc to offset our business travel emissions.

Declaration and Sign Off

This Carbon Reduction Plan has been completed in accordance with PPN 06/21 and associated guidance and reporting standard for Carbon Reduction Plans.

Emissions have been reported and recorded in accordance with the published reporting standard for Carbon Reduction Plans and the GHG Reporting Protocol corporate standard and uses the appropriate Government emission conversion factors for greenhouse gas company reporting.

Scope 1 and Scope 2 emissions have been reported in accordance with SECR requirements, and the required subset of Scope 3 emissions have been reported in accordance with the published reporting standard for Carbon Reduction Plans and the Corporate Value Chain (Scope 3) Standard.
