**CO-LEAD COUNSEL'S MOTION FOR AN AWARD OF  
ATTORNEYS' FEES AND PAYMENT OF EXPENSES**

1. Pursuant to Pa. R. Civ. P. 1716, Co-Lead Counsel, Labaton Sucharow LLP, Thornton Law Firm LLP, and Pomerantz LLP, hereby respectfully request, on behalf of Plaintiff's Counsel, in connection with the proposed settlement of the above-captioned class action: (i) an award of attorneys' fees in the amount of 33 1/3 % of the Settlement Fund, including accrued interest; (ii) payment of litigation expenses incurred by Plaintiff's Counsel in the amount of \$86,071.14, plus accrued interest; and (iii) an award of \$15,000 to Lead Plaintiff Gregory S. McComas for his efforts on behalf of the proposed Settlement Class.

2. The Court has scheduled a hearing on the motion for December 14, 2030 at 1:30 p.m.

3. The motion is supported by the accompanying memorandum of law and the Declaration of Jonathan Gardner in Support of (I) Lead Plaintiff's Motion for Final Approval of Class Action Settlement and Plan of Allocation and (II) Co-Lead Counsel's Motion for an Award of Attorneys' Fees and Payment of Expenses, with annexed exhibits, filed herewith.

4. A proposed Final Order and Judgment, negotiated by the Parties as part of the Settlement, is also submitted herewith.

5. Members of the Settlement Class have until November 23, 2020 to object to the requested relief.
