



**PLAINTIFF'S COUNSEL'S MOTION FOR AN AWARD OF ATTORNEYS'  
FEEs AND PAYMENT OF EXPENSES**

1. Pursuant to Pa. R. Civ. P. 1716, Plaintiff's Counsel, Labaton Sucharow LLP and Goldman Scarlato & Penny, P.C., hereby respectfully request, in connection with the proposed settlement of the above-captioned class action: (i) an award of attorneys' fees in the amount of 16% of the Settlement Fund, including accrued interest; (ii) payment of litigation expenses incurred by Plaintiff's Counsel in the amount of \$251,825.17, plus accrued interest; and (iii) an award of \$21,602.50 to plaintiff Public Employees' Retirement System of Mississippi.

2. The Court has scheduled a hearing on the motion for October 21, 2019 at 1:30 p.m.

3. The motion is supported by the accompanying memorandum of law and the Declaration of Serena P. Hallowell in Support of (I) Plaintiff's Motion for Final Approval of Class Action Settlement and Plan of Allocation and (II) Plaintiff's Counsel's Motion for an Award of Attorneys' Fees and Payment of Expenses, with annexed exhibits, filed herewith.

4. A proposed Final Order and Judgment, negotiated by the Parties as part of the Settlement, is also submitted herewith.

5. Defendants take no position on the relief requested.
