





2025 EMS Workforce Scholarship

2025 MDHHS EMS Workforce Grant – Now Open Deadline | May 16, 2025 Performance Period | Oct 1, 2024 – Sept 30, 2025

Goal: Address Michigan's paramedic shortage through funded training.

Scholarship Options:

Track 1: Up to \$20,000 for paramedic program tuition.
Track 2: Up to \$16,000 (\$15/hr) for EMS training time (agencies only).

Priority Groups:

Rural EMS, single parents, women, minorities, veterans.

Key Information:

- Schools/agencies must apply for students.
- 2-year MI service commitment required.
- Enrollment proof due by Aug 31, 2025.
- Repayment required if program isn't completed.
