OCHN's School Mental Health Navigators

- Mental Health School Navigators (MHSN) provide mental health and substance use outreach and resources to Oakland County schools.
 - Increase access to mental health services and supports for students.
 - Serve as the 'safety net' for students whose mental health needs require specialized interventions beyond what schools can provide.
- MHSNs connect youth and families to behavioral health and substance use supports, as well as financial assistance.





MHSN Program Goals

- Reduce barriers to mental health and substance use services.
- Increase awareness about service availability.
- Provide support and guidance to children, adolescents, and families.
- Identify income-based financial assistance and insurance co-pay benefits.





Massachusetts Youth Screening Instrument (MAYSI-2)

- Youth, age 11-17 years
- Measures 7 sub-categories:
 - Alcohol/Drug Use
 - Angry-Irritable
 - Depressed-Anxious
 - Somatic Complaints
 - Suicide Ideation
 - Thought Disturbance
 - Traumatic Experiences





MHA/JJD Project Overview (MAYSI-2)

- Project funded through Michigan Department of Health and Human Services
- Current Partners
 - Oakland Schools Truancy Department
 - Oakland County Circuit Court Family Division
 - Oakland County Public Schools
 - Pathways to Potential
- All children, age 6-17, who exhibit at-risk behavior are eligible for screening
- Referral source does not need to determine that the child has a mental health diagnosis
- Service is free for families



OCHN's New Youth and Family Care Connection Unit

- OCHN was awarded a grant from the Substance Abuse and Mental Health Services Administration (SAMHSA) to expand children's crisis services
- Renovated space at the Resource and Crisis Center in Pontiac
- Unit is for youth under the age of 17 years
- Reduce prolonged emergency room visits, ensuring families are connected to a continuum of care
