In my 22 years at MSU, I have significant administrative experience, serving as the Dept. Chairperson for the last 5 years and the Director of Graduate Students for 5 years as well. In addition, I taught the large-section principles courses for 7 years, teaching 1,200 students a year. Throughout this, I have interacted with many, many student athletes. I have a deep appreciation for the many incredible bids on their time and their commitment to excellence.

As Dept. Chair, I (1) wrote our dept. policy on advancing diversity, which passed unanimously among a very diverse group of faculty; (2) I created an administrative position (Director of Institutional Access) to assist me in achieving our diversity goals; (3) I continually advocate for a broad view of diversity, which is appropriate given we are a very large university; and (4) I routinely remind stakeholders of MSU's very rich history in promoting equitable access, especially among our athletic programs.
