A regular meeting of the Faculty Senate was held on October 14, 2025, at 3:15 pm via Zoom with Chairperson Angela Wilson presiding. The agenda was approved as presented. The minutes of September 16, 2025, meeting were approved as presented.

## **Remarks**

President Kevin Guskiewicz, Provost Laura Lee McIntyre, and Chairperson Wilson provided remarks to the Faculty Senate.

## **One Team One Health Survey Update- Ad hoc Committee**

Senator Cunningham provided an overview of the One Team, One Health (OTOH) faculty survey conducted September 29–October 9, 2025. The survey received 1,244 responses with an 83% completion rate, representing a broad cross section of faculty perspectives from affected and non-affected colleges. Senator Cunningham thanked the One Health Council members and Academic Governance staff for their assistance in developing and distributing the survey. She highlighted recurring themes from the qualitative feedback, a desire for greater transparency and communication; questions regarding the initiative's scope, timing, and implications for accreditation and faculty governance; and support for continued consultation and shared governance throughout the process.

Following discussion, members deliberated on how to share results while maintaining confidentiality and accuracy of interpretation. At-Large Member Lipton moved that the aggregate university-level survey summary be released to all Faculty Senators and that college-level reports be shared only with the five directly impacted colleges (Human Medicine, Osteopathic Medicine, Nursing, Agriculture and Natural Resources, Communication Arts Science and Education).

Chair Wilson thanked the survey team and faculty participants for their engagement and reiterated that no decisions have been made regarding the OTOH proposal, which remains in an exploratory phase. Additional data and task force reports will be circulated when available.

## **Board of Trustees Summit**

Senators Lipton and St. Charles provided an overview of the Board of Trustees' inaugural Stakeholder Summit, which replaced one of the Board's regular meetings this year.

The Summit was designed to create more meaningful engagement between the Board and university stakeholders, moving beyond the limited public comment format of regular meetings. Discussions centered on five thematic areas: health and well-being; community and civic engagement; university extension and outreach; MSU's research enterprise; facilities planning; and the undergraduate experience.

The discussions were productive, and trustees appeared engaged and receptive. The senators emphasized the value of expanding participation in future summits to better include those directly affected by the issues discussed.

Senator St. Charles also suggested that future stakeholder events should supplement not replace a formal Board meeting, as skipping a regular business meeting created an extended gap in Board action. Both senators agreed the Summit was a promising first step toward more transparent and informed dialogue between trustees and the university community.

## **Working Group on Faculty Conflict Resolution**

Senator Alan, Chair of the University Committee on Faculty Affairs (UCFA), provided an update on the ad hoc Working Group on Faculty Conflict Management. The group was initially formed to explore gaps in addressing faculty to faculty during conflicts within existing university processes.

With the recognition of the new faculty union, the working group's activities were temporarily paused to ensure compliance with labor law. Senator Alan shared that after recent consultation with the Office of General Counsel and FASA, the group may now be able to resume its work. A review of the charge and scope of the group is underway; if no substantive changes are required, the group will proceed under its existing charge. If changes are needed, UCFA will reconvene to update the charge and seek faculty input.

## **Academic Specialist Advisory Committee**

Secretary Cuellar provided an informational update regarding Academic Specialist representation in Academic Governance. She explained that the Academic Specialist Advisory Committee (ASAC) was notified last April that it did not have representation on the Faculty Senate or University Council due to those seats not being codified in the Bylaws.

Over the summer, the Office of Academic Governance began working to identify solutions and potential bylaw amendments to address this gap. This matter will be referred to the University Committee on Academic Governance (UCAG) for review and possible recommendations.

## **Loss of Title VI Funding and the future of Area Studies programs and loss of funding for migrant education programs (CAMP) at MSU**

Vice Chair Aerni-Flessner gave remarks on the recent loss of federal funding from the U.S. Department of Education affecting several long standing MSU programs, including the College Assistance Migrant Program (CAMP) and Title VI National Resource Center grants.

The CAMP program, previously funded at approximately \$400,000 annually, supports students from migrant and seasonal farmworker backgrounds. Although MSU has temporarily bridged the program through the Office of Undergraduate Education, the number of students served has been reduced.

Additionally, the elimination of Title VI funding impacts MSU's African Studies, Asian Studies, and Latin American and Caribbean Studies programs, as well as the International Business Center and the Less Commonly Taught Languages Center, totaling approximately \$2.2 million in lost annual support.

These programs are critical to MSU's global mission, graduate training, and distinction as an AAU member institution. Vice Chair Aerni-Flessner urged continued discussion on sustainable funding strategies and the importance of preserving these academic centers.

## **Resolution on COMPACT**

Vice Chair Aerni-Flessner introduced a resolution urging the University President and Board of Trustees to reject participation in the federal "Compact for Academic Excellence in Higher Education." The resolution cites concerns that the compact terms would infringe upon academic freedom and institutional autonomy.

Aerni-Flessner explained that the resolution was modeled on a similar statement adopted by the University of Virginia Faculty Senate and that recent reports indicate the offer may have been extended to all U.S. institutions.

The motion was seconded and passed with the majority voting in the affirmative. The resolution will be shared with the President and Board of Trustees and posted publicly on the Academic Governance website.

*Whereas,* the United States Secretary of Education has requested that nine other universities enter in a “Compact for Academic Excellence in Higher Education,” and

*Whereas,* the “Compact” contains provisions antithetical to the missions and traditions of the public, land-grant universities, and

*Whereas,* the “Compact” violates long-standing legal decisions regarding the First<sup>[ii](#)</sup> and Fourteenth<sup>[iii](#)</sup> Amendments, and violates the Unconstitutional Conditions Doctrine of the Supreme Court of the United States,<sup>[iiii](#)</sup> and

*Whereas,* Michigan State University stands for American academic values of the highest standard, including universal right to free speech<sup>[v](#)</sup> and academic freedom<sup>[vi](#)</sup>; therefore be it,

*Resolved,* That the Faculty Senate of Michigan State University firmly opposes the “Compact”, and

*Resolved,* That the Faculty Senate of Michigan State University stands in solidarity with faculty, students, and staff at other institutions rejecting the “Compact”, and

*Resolved,* That the Faculty Senate calls on President Guskiewicz and the Board of Trustees to reject this, or any similar compact that compromises the mission, values, and independence of Michigan State University.

<sup>[ii](#)</sup> Section 2 of the “Compact” forces signatory institutions to “transform or abolish institutional units that purposefully punish, belittle, or even spark violence against conservative ideas” thereby granting special favor for a particular viewpoint. This is a violation of the First Amendment.

[iii](#) Section 6 of the “Compact” mandates institutions “commit to defining and otherwise interpreting ‘male,’ ‘female,’ ‘woman,’ and ‘man’ according to reproductive function and biological processes.” This is designed to exclude transgender individuals from single-sex spaces and sports and would likely be challenged as unconstitutional sex-based discrimination under the Equal Protection Clause of the 14<sup>th</sup> Amendment.

[iiii](#) **The Unconstitutional Conditions Doctrine** holds that the government cannot use its power to grant benefits (like federal funding) to indirectly coerce people or institutions into giving up their constitutional rights. The entire idea of a compact is based on the premise that an institution must agree to these terms of ‘elect to forego federal benefits’ including student loans, research funding, and the institution’s tax-exempt status. These and other provisions are financial inducements that are so great that they become coercive and, therefore, an unconstitutional violation of state and institutional autonomy.

[v](#) Section 8 of the “Compact” requires universities to “screen out [foreign] students who demonstrate hostility to the United States, its allies, or its value.” This would require an institution to deny admission based on an applicant’s political beliefs. This would be a form of viewpoint discrimination that violates First Amendment principles.

[vi](#) Section 4 of the “Compact” requires university employees to “abstain from actions or speech relating to societal and political events” which runs afoul of courts recognition that academic speech related to scholarship and teaching warrants special protection under the First Amendment.

## Vacancy in Student Affairs Vote

Senator Gardner presented a motion to approve Emily Abrams as a replacement member for the University Committee on Student Affairs, filling the vacancy created by Emily Langhart’s departure. The motion was seconded and approved unanimously.
