A regular meeting of the University Council was held on October 28, 2025, at 3:15 PM via Zoom with Provost Laura Lee McIntyre presiding. The agenda was approved as presented. The minutes of September 30, 2025, meeting were approved as presented.

## **Remarks**

Provost Laura Lee McIntyre, and Faculty Senate Chairperson Angela Wilson, provided remarks to the University Council.

## **Survey on Digital Learning Platforms**

The ad hoc committee chaired by Chastity Warren was charged by the University Council to review MSU's use of complementary digital learning platforms through student and faculty surveys distributed in Fall 2024. Student responses showed that while digital tools are widely used—with D2L as the main hub and other tools like Piazza, Zoom, Gradescope, and Packback supplementing instruction students face challenges with inconsistent tool use across courses, multiple logins, non-intuitive platforms, and uneven costs. Their priorities centered on clarity, ease of use, affordability, accessibility, and stronger integration with D2L.

Faculty responses (258 total) confirmed that D2L is central to MSU's teaching environment but is often supplemented with both supported tools (Kaltura MediaSpace, Teams, Gradescope) and non-supported tools (Google Workspace, publisher platforms), indicating unmet needs. Faculty emphasized tools that support grading, content delivery, assignments, and assessments. Chair Warren reported that the committee recommends improving platform integration, evaluating support for high-performing tools, monitoring emerging technologies, and investing in faculty development.

## **Update from Council of Graduate Students COGS**

Vice President for Internal Affairs Nic Heilman provided an update for COGS. He reported strong engagement from graduate and professional students, noting that COGS has already held two full council meetings and continues working to reengage departments that have been less active in recent years. COGS has hosted a wide range of weekly social events, offered multiple sponsorships for workshops and conferences, and is preparing for its 17th Annual Graduate



Academic Conference on February 21, 2026, with abstract submissions open through January 16. Heilman noted growing financial strain on graduate and professional students, citing rising funding requests, limited university-wide support, competitive positions, and program moratoriums that disrupt cohorts, culture, and course availability. He highlighted concerns about cuts to required courses, such as a recently removed bioinformatics class, and emphasized the need for transparency and timely communication. He closed by reaffirming that MSU's success depends on supporting graduate and professional students and expressed COGS's commitment to continued collaboration with university leadership.

### **Loss of Title VI Funding and the future of Area Studies programs and loss of funding for migrant education programs (CAMP) at MSU**

Vice Chair John Arne Flessner provided an update on the significant loss of federal funding impacting MSU's College Assistance Migrant Program (CAMP) and several Title VI National Resource Centers. CAMP, which previously received more than \$400,000 annually and supported 50–60 migrant students each year, has been cut and temporarily bridged by MSU's Office of Undergraduate Education but with reduced student enrollment. Additionally, all Title VI funding totaling roughly \$2.2 million annually has been eliminated for MSU's African Studies, Asian Studies, Latin American and Caribbean Studies, Broad's International Business Center, and MSU's National Less Commonly Taught Languages center. These cuts threaten MSU's ability to support language study, graduate training, professional development, and scholarly publishing. Vice Chair Flessner emphasized that these centers have long distinguished MSU within the AAU and are central to the university's mission and global engagement. He urged a campus discussion on sustaining these programs and welcomed suggestions and stories illustrating their impact.

### **Graduate Program Update**

Dean Pero Dagbovie, joined by UCGS Chair A.J. Robison, provided an update on graduate programs, focusing on the recent rise in moratoria and temporary admissions pauses for Ph.D. programs. He explained that MSU currently has 11 Ph.D. programs under formal moratoria and nine additional programs with emergency admissions holds for 2026–27, driven by budget constraints, federal funding uncertainty, and national trends affecting graduate education. pauses allow programs to reassess structure, funding, and long-term sustainability, but they will likely result in lower Ph.D. enrollment next year, potentially a 20% reduction. Both speakers emphasized that the issue mirrors challenges across the Big Ten and the AAU, where some universities are pausing additional programs.
