2001-2014 Director, School of Criminal Justice, MSU

Chief academic and administrative officer of the School of Criminal Justice responsible for leading the School in all aspects of teaching, research/scholarly activity, service and fundraising. Responsible for administration of School with 28 tenure stream faculty, 34 research, teaching, outreach and advising specialists, 9 support staff, and 35 graduate assistants. During this period, the School had a base budget of \$2.7 million, an additional \$1.1 million in non-base funding, and an annual average of \$4-5 million in external grant funding. Tenure involved a period of significant fiscal challenge for the state and the university with significant reductions in state funding. Through extensive internal and external partnerships and increased interdisciplinary activity, the faculty grew from a low point of 15 in 2004-05 to 28 in 2014. Levels of external funding increased with the School consistently being rated as first or second in annual surveys of doctoral programs in criminal justice and criminology as well as within the College of Social Science.
