Michigan Center for Rural Health Awarded HRSA Rural Health Care Services Outreach Grant



The Michigan Center for Rural Health has been awarded a \$250,000 annual grant from the U.S. Department of Health and Human Services, Health Resources and Services Administration (HRSA) through the Rural Health Care Services Outreach Program. This funding is part of more than \$15 million awarded to 58 recipients in FY2025 to improve access to care and health outcomes in rural communities.


This new four-year initiative (Advancing Health in Rural Michigan) builds on the success of MCRH's *Healing Close to Home* project, which expanded hospital-based transitional care in rural Michigan. The new effort will continue advancing rural post-acute care while adding a strong focus on community wellness and planning for end-of-life care, ensuring patients and families are supported throughout the full continuum of care.

Projects under HRSA's Outreach Program foster collaboration among local networks, use evidence-informed models, and address rural-specific needs such as chronic disease prevention, care coordination, and improved access to services.

MCRH is excited to continue and expand the work we began through the *Healing Close to Home* Outreach project. By integrating wellness initiatives with thoughtful end-of-life care planning, we can help rural Michiganders live well and age with dignity, right in their home communities.

This month's Rural Spotlight shines on the Michigan Assistive Technology Program (MATP), a statewide initiative helping people with disabilities and older adults access tools that make daily life easier, no matter where they live.

From simple, low-tech aids like jar openers and magnifiers to high-tech solutions like communication devices and smart home tools, assistive technology (AT) can transform independence, safety, and participation in everyday life.

MATP offers:

• Free device demonstrations to compare options and see what works

best.

- Equipment loans for 14–45 days so you can try AT in your own environment.
- One-on-one training and support to build comfort and confidence with your chosen tools.

What makes MATP unique is its ability to serve all 83 Michigan counties, including the most rural communities. Their team meets people where they are, whether at home, work, or in the community, breaking down transportation barriers and ensuring no one is left without access.

MATP's work reminds us that rural health is about access, equity, and the tools that help people thrive in their own communities, because when the right technology meets the right support, the possibilities are endless.

2024 CMS Star Ratings: Recognizing Excellence in Michigan Rural Healthcare Facilities



The Centers for Medicare & Medicaid Services (CMS) recently released the highly anticipated 2024 CMS Star Ratings. The CMS Star Ratings system evaluates various aspects of healthcare facilities, including clinical outcomes, patient experience, safety, and more. These ratings not only serve as a guide for patients seeking high-quality care but also encourage healthcare providers to continuously improve and strive for excellence. The star ratings range from one to five stars, with five stars indicating the highest level of quality and performance.

One notable aspect of the 2024 CMS Star Ratings is the recognition of exceptional rural healthcare facilities that have consistently delivered outstanding care to their communities.

Among these standouts are 7 rural Prospective Payment System (PPS) facilities and 6 Critical Access Hospitals that proudly received star ratings. These facilities have proven their commitment to excellence in patient care and clinical outcomes. Most Critical Access Hospitals don't receive a CMS Star Rating because low patient volumes and limited measure eligibility prevent

them from meeting the program's minimum reporting requirements, even when they deliver high-quality care making the achievements of this year's rated CAHs especially noteworthy.





MDHHS Behavioral Health Internship Stipend Program Application Cycle Now Open!



The Michigan Behavioral Health Internship Stipend Program (MI-BHISP) aims to increase the number of qualified behavioral health professionals in Michigan by providing a stipend of up to \$15,000 to eligible student interns. MI-BHISP stipends are intended for interns who are in the process of completing a bachelor or graduate level behavioral health degree program that leads to a behavioral health profession dedicated to serving children.

The internship must be completed in the Michigan public behavioral health-based system defined as a local prepaid inpatient health plan, community mental health service program or subcontracted entity, Indian Health Service/Tribally Operated Facility or program/Urban Indian Clinic.

This application cycle closes on August 31st, 2025.


September is National Recovery Month!

Register for the Bureau of Indian Affairs Sixth Annual Opioid Summit



The Bureau of Indian Affairs and the Saginaw Chippewa Indian Tribe are proud to present the sixth annual Opioid Summit, Journey of Hope: Paths to Positive Change in the Opioid Crisis. This important one-and-a-half-day conference will take place on Wednesday, November 5, and Thursday, November 6, 2025, at the Soaring Eagle Casino & Resort Entertainment Hall in Mt. Pleasant, MI.

This summit welcomes all individuals and communities impacted by or working to address the opioid crisis. Attendees will include a diverse network of professionals and advocates, including:

- Victim service providers
- Law enforcement officers

- Emergency response personnel (EMTs, paramedics)
- Health care professionals
- Educators and community organizers
- Human service and court personnel
- Therapists, addiction and recovery specialists
- Students and anyone passionate about healing and change

The goal of the summit is to foster collaboration, share resources, and inspire hope and positive action in the fight against the opioid epidemic.

This event reflects the Bureau of Indian Affairs' mission: to enhance the quality of life, promote economic opportunity, and carry out the responsibility to protect and improve the trust assets of American Indians, Indian tribes, and Alaskan Natives.

RX Kids



Rx Kids is Michigan's first *universal*, *unconditional cash prescription program* designed to support pregnant women and infants. Under the program, expecting mothers receive \$1,500 during pregnancy, followed by \$500 per month for the first 6–12 months of their child's life. The program's goal is to improve child health outcomes and strengthen family economic stability by reducing poverty—an especially critical issue in rural communities where families often face limited healthcare access, transportation barriers, and job insecurity.

Unlike traditional assistance programs, Rx Kids has no income limits. It is truly universal and unconditional.

To date, the program has distributed more than \$10 million to over 2,500 families statewide. Participants consistently report high satisfaction, with many noting that the financial support allows them to focus on their health and their baby's wellbeing instead of worrying about basic needs.

Expansion to Rural Michigan

On March 3, 2025, Rx Kids expanded to the Eastern Upper Peninsula (EUP), serving families in Alger, Chippewa, Luce, Mackinac, and Schoolcraft counties. Early outcomes demonstrate meaningful impact: \$812,500 in cash prescribed, 323 families enrolled, and 189 babies born. Local mothers, including one from Sault Ste. Marie, have shared how the program eased financial stress during pregnancy, allowing them to focus on their health and prepare for their baby's

arrival. The EUP effort is supported by the Luce Mackinac Alger Schoolcraft (LMAS) Health Department and the Chippewa County Health Department, ensuring strong local partnerships.

Clare County launched its Rx Kids program on August 1, 2025, administered by the Central Michigan District Health Department (CMDHD). Backed by MyMichigan Health and the Clare Community Foundation, the program is projected to serve approximately 300 families each year. Families in Clare County already report reduced stress and an improved ability to cover essential needs such as diapers, formula, and rent.

Program Impact

Early results demonstrate Rx Kids' broad and lasting impact:

- 88% of participants report feeling more financially secure and better able to meet essential needs during pregnancy and early parenting.
- Families report significantly reduced stress, leading to healthier pregnancies and stronger starts for infants.
- Economically, the program generates a \$1.57 return to the local economy for every \$1 distributed, underscoring its value not only for families but also for entire communities.

Rx Kids has garnered bipartisan support in Lansing, where discussions are underway about expanding the program to additional counties—or even statewide. Leaders see it as an efficient, dignified alternative to traditional assistance models.

For rural counties such as Clare and those in the EUP, Rx Kids provides more than financial aid—it strengthens community wellbeing. By offering unconditional cash support during pregnancy and early childhood, the program promotes family stability, reduces stress, and helps infants grow into healthy children. Grounded in dignity and rural equity, Rx Kids is becoming a model for Michigan and a blueprint for regions across the nation.

NARHC Research and Education Foundation Launches Fall Scholarships!



The NARHC Research and Education Foundation (REF) has opened applications for the Fall 2025 Quest for Rural Experience Scholarships. Each \$3,000 award supports Nurse Practitioner or Physician Assistant/Associate students completing clinical rotations in Rural Health Clinics, helping cover expenses such as housing, transportation, and other educational needs. This fall, NARHC REF plans to award four scholarships.

Established in 2021, NARHC REF works to advance research on the role of RHCs in improving access to care and provides financial support to students training in rural settings.

Past recipients describe the program as transformative, citing experiences that strengthened their skills, deepened relationships with patients, and reinforced their commitment to serving rural communities.

RHCs hosting eligible students are encouraged to share this opportunity.



SAMHSA Releases Annual National Survey on Drug Use and Health



The Substance Abuse and Mental Health Services Administration recently released the results of its survey conducted every year, a national snapshot based on self-reported responses from nearly 70,000 people. This year marks the first year since 2020 in which there are at least four years of comparable data for key NSDUH outcomes to enable reporting of trends. Along with use of both legal and illicit substance use, SAMHSA's report tracks nine indicators of mental health, including anxiety, depression, mental illness, and suicidal thoughts, plans, and attempts.

Some key findings:

- Among adolescents aged 12 to 17 years in 2024, 18.8% (nearly 1 in 5)
 had moderate or severe symptoms of generalized anxiety disorder (GAD)
 including 10.6% who had moderate symptoms and 8.2% who had severe
 symptoms.
- Among adolescents aged 12 to 17, the percentage who had serious thoughts of suicide in the past year declined from 12.9% in 2021 to 10.1% in 2024.
- Among adolescents aged 12 to 17, the percentage who had a major depressive episode in the past year declined from 20.8% in 2021 to 15.4% in 2024.
- The percentage of people 12 or older with a drug use disorder in the past year increased from 8.7% in 2021 to 9.8% in 2024.
- The percentage of people 12 or older with an alcohol use disorder in the past year decreased from 10.6% in 2021 to 9.7% in 2024.
- In 2024, among adults aged 18 or older, 33.0% (or 86.6 million people) had either AMI or an SUD in the past year.
- During the past year, 25.5 percent of people 12 and older said that they'd used an illicit drug.
- Meanwhile, those who said they participated in binge drinking dropped slightly from 21.7 percent in 2021 to 20.1 percent in 2024.

This resource is a complement to the federal Centers for Disease Control and Prevention report last year which found that between 2000 - 2020, suicide rates almost doubled in rural areas.

CMS Proposes Updates to Medicare Physician Fee Schedule Payments for Calendar Year 2026 – Comment by September 12



This proposed rule from the Centers for Medicare & Medicaid Services (CMS), issued on July 16, 2025, seeks public comment on payment updates and policy changes to Medicare's physician fee schedule payments and includes other proposals affecting Medicare beneficiaries.

Proposals include removing the code and add-on payment for the Social Determinants of Health Risk Assessment, permanently adopting the definition of direct supervision that allows the physician or supervising practitioner to provide supervision through real-time audio and visual interactive telecommunications (excluding audio-only), creating an optional add-on codes for Advanced Primary Care Management (ACPM) services that would provide behavioral health integration or psychiatric Collaborative Care Model (CoCM) services proposed modifications to the way that CMS will pay for skin substitutes, a proposed negative 2.5 percent adjustment to certain non-time-based Relative Value Units (RVUs), and a new mandatory alternative payment model, the Ambulatory Specialty Model.

The proposed rule also includes proposed updates applicable to **Rural Health Clinics** (RHCs), including extending non-behavioral health telehealth flexibilities through December 31, 2026, requiring an in-person mental health service within 6 months prior to the mental-health telehealth visit and requiring an in-person mental health visit every 12-months while the patient is receiving services, requiring RHCs and FQHCs to report and bill the individual codes for BHI and CoCM rather than the current consolidated code.
