This month, we're spotlighting **Grow Benzie**, a rural hub in Benzie County that's redefining what community support looks like. What began as an abandoned plant nursery has evolved into a *Rural Prosperity Incubator*, providing fiscal sponsorship, grant writing, shared space, and backbone services that support local leaders and nonprofits in their growth and success.

One powerful example is *Stories That Heal*, a youth-and-senior-led project breaking mental health stigma through storytelling. With Grow Benzie's support, this grassroots idea connected with schools and local partners, reaching a broader audience and gaining vital resources.

Grow Benzie shows that supporting rural health and wellbeing goes beyond clinical care. It includes strengthening food access, housing, education, and the connections that bring communities together.

Applications Now Open for Fall 2025 Cohort of the Rural Hospital Stabilization Program (RHSP)



The Rural Hospital Stabilization Program (RHSP) is an initiative of the Health Resources and Services Administration's (HRSA) Federal Office of Rural Health Policy and is now accepting applications for its Fall 2025 cohort. This nationally supported program helps rural hospitals improve financial stability, expand essential services, and ensure care remains close to home through comprehensive assessments, planning, and customized support. The RHSP project is fully funded by the Health Resources and Services Administration (HRSA).

Who is Eligible?

- Critical Access Hospitals (CAHs)
- Prospective Payment System (PPS) Hospitals
- Rural Emergency Hospitals (REHs)
- Indian Health Service Hospitals

RHSP supports participating hospitals by:

- Conducting in-depth financial and operational assessments
- Guiding strategic service line expansion (e.g., behavioral health, pulmonary rehab)
- Offering one-on-one coaching and peer learning
- Enhancing data-driven decision-making and improving cash flow

The Joint Commission new hospital accreditation program, announced



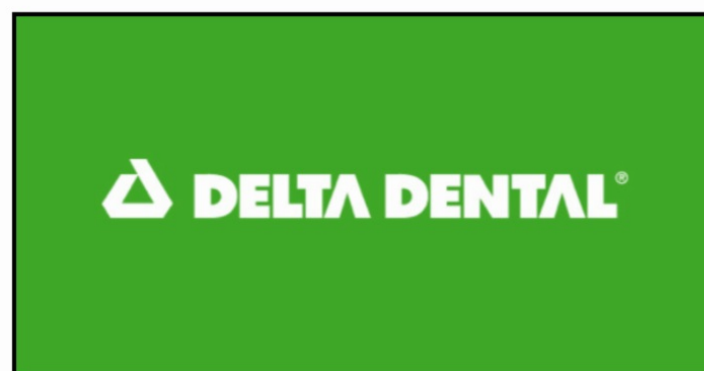
On June 30th, the Joint Commission **announced** a new program called Accreditation 360: The New Standard, which seeks to streamline its hospital accreditation process by removing 714 requirements from its hospital accreditation program. This includes an updated manual that identifies CMS Conditions of Participation (CoP) and a streamlined patient safety requirement called National Performance Goals. Specifically, the goals of the program are divided into four sections:

1. Simplified Accreditation Process
2. Streamlined Patient Safety Practices
3. Certifications Focused on Outcome Measures
4. Broadened Resources

Educational Opportunity: Obstetric Readiness for EMS and EDs in Rural Communities



ALLIANCE FOR INNOVATION

To support rural providers in preparing for the CMS changes, the Federal Office of Rural Health Policy (FORHP) is launching a five-part Learning Series on Obstetric Readiness which began June 25th and will end August 13th. This free Zoom-based series is specifically geared toward emergency medical services (EMS) and emergency department (ED) teams in rural and under-resourced communities.

Hosted by the Alliance for Innovation on Maternal Health (AIM) and funded by the Health Resources and Services Administration (HRSA)'s Maternal and Child Health Bureau, the series highlights opportunities for collaboration between EMS, hospitals, and community partners. Topics include the use of telehealth, mobile care units, and community resource networks to improve care for pregnant and postpartum patients.

Each session is 75 minutes long, with the first focusing on rural obstetric care challenges and community-based solutions. This learning opportunity builds on previous AIM work, including the [AIM Obstetric Emergency Readiness Resource Kit](#).

Low-Cost Visual Aids Support Medication Management in Primary Care

Having access to quick resources that are easily available and well-designed are useful in busy primary care clinics, especially those that may have limited resources. Through the Quality Improvement (QI) Program at Western Michigan University Homer Stryker MD School of Medicine, visual aids were created to do just that.

Based on the [Allergy and Immunology inhaler poster](#), the team created and distributed medication posters that treat [diabetes](#), [heart failure](#), and [weight management](#). These posters were easy to design and are low-cost to distribute and display. Overall, the posters were well-received and continue to be utilized years after the QI project was conducted.

New Research: The Impact of High Hospital Fixed-Cost Ratios on Rural Populations



This brief focuses on rural hospitals with high fixed-to-total-cost ratios and

describes characteristics of those hospitals and the communities they serve. The brief extends a recent RUPRI Center analysis of whether hospitals in rural areas have higher fixed-to-total-cost ratios, a characteristic that has implications for financial stability under different payment models. Key findings include: 1.) Fixed-to-total-cost ratios vary along the rural continuum; recent RUPRI research found that hospitals in noncore counties without towns of at least 2,500 people have the highest ratios, with a median estimate of 0.933 (where 1 means 100 percent of costs are fixed).

Moreover, groups of distinct fixed-to-total-cost profiles emerged based on Urban Influence Codes (UICs). 2.) As UIC groups become more rural, hospitals' estimated fixed-to-total-cost ratios increase; populations in those UIC groups tend to be older, more likely to be on Medicare or Medicaid, less likely to have a college education, and less likely to have employer-sponsored insurance. 3.) Because the level of rurality itself matters, policymakers could identify ways that this insight could be used to refine payment policies to better support all Americans' access to hospital services

NRHA Resources related to Rural Hospital Transformation Program



Last week, Congress passed the *One Big Beautiful Bill Act*, which included the new Rural Health Transformation Program (RHTP). The Program includes \$50 billion over 5 years for states to carry out certain activities to improve rural health care access and delivery.

While questions still remain regarding applications for the program and implementation, NRHA created a comprehensive summary of the RHTP provisions included in the bill.

Medicare Advantage Beneficiaries Have Longer Hospital Stays Than Those with

Traditional Medicare

A June 2025 NORC study found that Medicare Advantage (MA) beneficiaries had significantly longer hospital stays before being discharged to post-acute care settings compared to traditional Medicare beneficiaries. From 2018 to 2022, MA discharges to post-acute care rose by 5.6%, while traditional Medicare discharges declined slightly, with MA patients consistently experiencing longer stays across all care types, most 22 days versus 13 days in long-term acute care.

Although the analysis was age-adjusted, it did not control for clinical or demographic factors, prompting calls for further research to better understand the coverage-related drivers behind these differences.

Deadly Opioid Carfentanil Reemerges in Michigan

11 Associated Deaths recorded Since January - *MDHHS urges actions to prevent fatal overdoses.*

The Michigan Department of Health and Human Services (MDHHS) is warning Michigan residents about carfentanil, a potent fentanyl alteration that is

reemerging in the unregulated drug supply and contributing to overdose deaths.

Carfentanil is a synthetic opioid. It is approximately 10,000 times more potent than morphine and 100 times more potent than fentanyl. Carfentanil was developed for veterinary use with large animals and is not approved for use in humans.

“Carfentanil is an extremely potent and deadly drug,” said Dr. Natasha Bagdasarian, chief medical executive. “We’re urging people who use unregulated drugs – and their loved ones – to carry naloxone, an easy to administer nasal spray that can reverse opioid overdoses and save lives. Awareness and quick action can help save lives.”

Between January and June 2025, 11 deaths involving carfentanil were identified. The deaths occurred in Ingham, Livingston, Eaton, Genesee, Oakland and Wayne counties. None of the deaths were positive for carfentanil alone; 10 individuals also tested positive for cocaine and fentanyl was found in eight cases.

Carfentanil was previously seen in Michigan in 2016 and 2017, contributing to 107 deaths in 2016 and 111 in 2017. Carfentanil-related deaths dropped to counts less than five in 2018, 2019, 2020, then zero in 2021 and 2022. Finalized data identified 14 deaths in late 2023 as involving carfentanil.

Analysis of recent provisional data from MDHHS indicates a 34% reduction in overdose deaths from 2,931 deaths in 2023 to a projected 1,927 in 2024. Carfentanil reemerging in the unregulated drug supply could impact future improvements and is concerning for these reasons:

- Its higher strength could lead to more overdoses and overdose-related deaths, even for people with a high tolerance for opioids.
- It quickly causes central nervous system depression, which can lead to rapid death.
- Its higher strength could require multiple doses of naloxone to be administered to reverse an overdose.
- It is increasingly found among overdose deaths that also include cocaine, methamphetamine and other stimulants. People may use these drugs and not be aware they could contain carfentanil.

MDHHS is urging the following actions:

- **Carry naloxone.**
- Residents and organizations can request free naloxone through the **MDHHS naloxone request form** or through a pharmacy; **no prescription required.**
- Contact a **harm reduction agency** for naloxone.
- **Use harm reduction strategies to lessen the risk of overdose.**
- This includes using less and taking it more slowly, carrying naloxone, not using yourself and monitoring breathing.

- Follow the [overdose response guideline](#) if you suspect someone is experiencing an opioid overdose:
- Evaluate for signs of [opioid overdose](#).
- Person is unconscious or unable to be awakened.
- Slow or shallow breathing difficulty such as choking sounds or a gurgling noise from a person who cannot be awakened.
- Fingernails or lips turning blue/purple/grey.
- Call 911 for help.
- Administer naloxone.
- If possible, support the person's breathing through rescue breathing.
- Get the person on their back, tip their head back to straighten the airway, pinch their nose, put your mouth over theirs and form a seal. Give one breath every five seconds. If you do not feel comfortable with this step, it is still important to call 911 and administer naloxone.
- Monitor the person's response.

MDHHS will continue monitoring for carfentanil among overdose deaths and will share additional information as it becomes available. Agencies aware of any carfentanil-involved overdoses or exposures since January 2025, should share this information at MDHHS-MODASurveillance@Michigan.gov.
