This month, we're proud to feature **Delta-Schoolcraft Great Start Collaborative** and their innovative intergenerational program **Stories and Crafts with Seniors** and **Tots**.

The Delta-Schoolcraft Great Start Collaborative works to identify local service gaps and create programs that help every child succeed. One such program is **Stories & Crafts with Seniors and Tots**, a monthly intergenerational story time at the Manistique Senior Citizens Center. The Delta-Schoolcraft Great Start Collaborative identified a gap in early childhood engagement and responded with a creative, community-centered solution.

Held every third Wednesday, the event brings together children ages 0–5 and local older adults for themed stories, crafts, and snacks. The program was launched through a partnership between the Senior Center and Schoolcraft Family Liaison Monica Powell. Rural communities thrive when generations come together and in Schoolcraft County, that's exactly what's happening.

## GVSU Expands Behavioral Health Training for Rural PAs with New HRSA Grant



Grand Valley State University's Physician Assistant Studies (PAS) program has been awarded a new HRSA grant titled "Addressing Behavioral Health Conditions in Rural Primary Care Through Enhanced Preceptor, Faculty, and Student Training and Experiential Learning." This initiative aims to grow the pipeline of PAs prepared to deliver high-quality behavioral health care in rural communities.

Building on the success of GVSU's rural northern Michigan campus—originally funded by HRSA in 2012—the new grant will support enhanced training for PA faculty and rural clinical preceptors, along with expanded student experiential learning. Key program components include:

• A 3-month integrated behavioral health clinical rotation for PA students in rural primary care settings

- Preceptor training through UMass Chan Medical School's Primary Care Behavioral Health Certificate (36 CME credits)
- Additional courses such as MOUD training and attendance at the Michigan Rural Health Conference
- Stipends of \$2,250 per student for preceptors, along with technology support (iPad provided for student/preceptor use)

Preceptors will host two students per year for 12-week rotations that span care across the lifespan and include at least ten behavioral health encounters weekly. Evaluations are completed mid- and end-of-rotation.

This comprehensive effort not only strengthens the rural primary care workforce but also builds long-term partnerships between education and practice sites, expanding access to behavioral health services across Michigan.

## Now Open: 2025 Investing in the Health of the Upper Peninsula Grant Opportunity







The Blue Cross Blue Shield of Michigan Foundation, in partnership with the Superior Health Foundation and the Michigan Health Endowment Fund, has recently announced the 2025 *Investing in the Health of the Upper Peninsula* Request for Proposal (RFP). This funding opportunity is designed to support programs that improve health outcomes across Michigan's Upper Peninsula, with a special emphasis on meeting the needs of the region's aging population.

Grant funding of up to \$50,000 is available for projects lasting 12 to 24 months. Priority areas include access to care, workforce development, chronic disease prevention, caregiving, social isolation, health literacy, and capacity building through data analysis.

Applicants must submit a concept paper by July 11, 2025, at 11:59 PM (ET) to be considered for full proposal submission. Selected applicants will be invited to submit full proposals by September 12, 2025.

## New Resource: CDC's Suicide Prevention Communication Campaign Playbook



The Centers for Disease Control and Prevention (CDC) released a new resource for planning suicide prevention campaigns. The playbook includes:

- **Key Audience**: Tools for identifying specific populations at higher risk and their networks of influence.
- Campaign Development: Steps to design effective strategies, craft meaningful messages, and promote behavior change.
- Behavior Models: Insights into frameworks like the Health Belief Model and Social Cognitive Theory.
- Messaging Best Practices: Strategies to emphasize hope and resilience and use culturally relevant language.
- Evaluation: Tools to measure campaign impact and improve future efforts.

The latest data from the CDC show that rural residents are at a higher risk for suicide than urban residents and that rates of suicide almost doubled between 2000-2020 in rural areas.

## CMS Finalizes New Standards to Strengthen Obstetrical Care in Hospitals and Critical Access Hospitals



In response to persistent gaps in maternal health outcomes and the need for consistent, high-quality obstetrical care across diverse healthcare settings, the Centers for Medicare & Medicaid Services (CMS) finalized a sweeping rule in November 2024 titled "Health and Safety Standards for Obstetrical Services in Hospitals and Critical Access Hospitals." The updated Conditions of Participation (CoPs) establish new federal requirements aimed at improving maternal and infant outcomes, ensuring safer and more coordinated care, and reducing disparities—particularly in rural and underserved communities.

The new rule applies to acute care hospitals and Critical Access Hospitals (CAHs) that provide obstetrical services or emergency care. Requirements will roll out in phases from mid-2025 through 2027, with additional interpretive guidance from CMS anticipated to assist in implementation. If deficiencies are found during a survey, facilities will first be required to submit a Plan of Correction before further action is taken.

#### Key Provisions of the Rule:

#### **Emergency Services Readiness**

Starting July 1, 2025, hospitals and CAHs with emergency departments must ensure staff are prepared to respond to obstetrical emergencies. Facilities are expected to adopt evidence-based protocols, maintain essential medications and equipment, and offer annual staff training informed by internal quality improvement data. Every emergency care area must also be equipped with a reliable system for patients to alert staff.

#### **Patient Transfer Policies**

Starting July 1, 2025, all hospitals must have written protocols in place for safely transferring patients within or outside the facility. Training on these procedures must occur annually for relevant staff. While CMS does not mandate written policies for accepting incoming transfers, it encourages

hospitals to consider them as a best practice.

#### Organization and Oversight of OB Services

Beginning January 1, 2026, facilities offering obstetrical services must ensure those services are organized in accordance with recognized clinical standards and integrated with other departments, such as surgery or anesthesia. OB services must be supervised by experienced clinical leaders, such as nurse practitioners, midwives, or physicians, and providers must have clearly defined clinical privileges.

#### Standards for Safe Care Delivery

Also effective January 1, 2026, hospitals must align their obstetrical services with the needs of their patient population and the hospital's capacity. This includes having protocols for emergency situations, appropriate monitoring equipment (e.g., fetal dopplers, cardiac monitors), and immediate access to supplies like hemorrhage carts or crash carts. CMS allows flexibility, with the expectation that each facility's equipment and resources reflect its service volume and complexity.

#### **Staff Training Requirements**

Starting January 1, 2027, OB staff must receive role-specific training at hire and at least every two years thereafter. These sessions must reflect quality improvement findings and focus on practices that enhance the safety and cultural responsiveness of obstetrical care. Hospitals have flexibility in training methods but are expected to regularly assess their effectiveness.

#### Integration with Quality Programs

Also by January 1, 2027, CMS will require OB services to be more fully integrated into each hospital's Quality Assurance and Performance Improvement (QAPI) program. Facilities must analyze obstetrical outcomes, identify disparities, and implement at least one measurable improvement project each year. Hospitals located in areas with a Maternal Mortality Review Committee (MMRC) must also incorporate publicly available MMRC data into their QAPI efforts.

#### **Next Steps**

Facilities are encouraged to begin reviewing their current operations, engaging clinical leaders, and updating policies and procedures ahead of the phased deadlines. Leveraging educational resources like the Obstetric Readiness Learning Series can support successful implementation and enhance care for all mothers and newborns.

Educational Opportunity: Obstetric Readiness for EMS and EDs in Rural Communities



To support rural providers in preparing for the CMS changes, the Federal Office of Rural Health Policy (FORHP) is launching a five-part Learning Series on Obstetric Readiness beginning June 25th. This free Zoom-based series is specifically geared toward emergency medical services (EMS) and emergency department (ED) teams in rural and under-resourced communities.

Hosted by the Alliance for Innovation on Maternal Health (AIM) and funded by the Health Resources and Services Administration (HRSA)'s Maternal and Child Health Bureau, the series highlights opportunities for collaboration between EMS, hospitals, and community partners. Topics include the use of telehealth, mobile care units, and community resource networks to improve care for pregnant and postpartum patients.

Each session is 75 minutes long, with the first focusing on rural obstetric care challenges and community-based solutions. This learning opportunity builds on previous AIM work, including the AIM Obstetric Emergency Readiness Resource Kit.


## Funding Opportunity for Community-based Organizations Working in Drowning Prevention

Financial Hardship by State: ALICE



United for ALICE recently released its 2025 report, revealing that 41% of Michigan households struggled to afford basic needs in 2023. While 14% lived below the federal poverty line, an additional 27% were classified as ALICE, working households that earn too much for assistance but not enough to meet rising costs for essentials like housing, food, and child care.

Rural communities are especially affected. Nationally, 44% of rural households are below the ALICE Threshold, with many working in low-wage essential jobs such as caregiving, retail, and food service. Older adults in rural areas are at greater risk as well, with over half of 65+ households experiencing financial hardship.

2025 National Shortage Designation Update in September - HPSA Updates & Rescore Process



Per federal regulations, Health Professional Shortage Area (HPSA) designations, including Maternity Care Target Areas (MCTAs) scores, are required to be updated every three years. As part of the Shortage Designation Modernization Project, the next National Shortage Designation Update (NSDU) is tentatively scheduled on *September 23, 2025*.

#### How to request a HPSA update or rescore:

- The Primary Care Office (PCO) must be contacted to request a shortage designation as the only entity that can submit a designation request to the federal government (HRSA) in Michigan. Requests are free and can be made by anyone in the community.
- Auto-Health Professional Shortage Area (HPSA) facilities can submit rescore requests through the Auto-HPSA Portal at any time using "An Auto-HPSA Point of Contact" link under the "Partners" tab here.
- Automatically designated facility HPSAs, per federal statute and regulations, include:
  - Federally Qualified Health centers/Look-alike (FQHC).
  - Indian Health Service, Tribal Clinic, and Urban Indian Health Clinic (ITU).
  - CMS-certified Rural Health Clinics (RHCs) meeting NHSC site criteria.
