

## BACK TO SCHOOL PROMOTION TERMS AND CONDITIONS

1. Participation in Orion Springfield Central Back to School Competition ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times and dates throughout these Terms and Conditions are based on Australian Eastern Standard Time (AEST) or Australian Eastern Daylight Savings Time (AEDST) as the case requires. The "Participating Centre" is Orion Springfield Central.
2. Subject to condition **4**, this Promotion is only open to Australian **residents aged 13 years or over**.
3. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to all terms and conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to this Promotion.
4. The following are ineligible: (i) employees of the Promoter, the Mirvac Group or any of the tenants or retailers in the Participating Centre or any of the Promoter's agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether by birth or adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter's promotions.

### PROMOTION PERIOD

### HOW TO ENTER

6. To enter, eligible individuals must, during the Promotion Period, visit the <https://www.orionspringfieldcentral.com.au/experience/offers/orion-back-to-school-prize> upload a photo or image of their receipt showing a purchase of \$10.00 or more (inclusive of GST) from any participating 'Back to School' retailer at Orion Springfield Central during the Promotion Period. Participating retailers exclude major retailers at Orion Springfield Central that sell back to school items, including but not limited to BIG W, Woolworths, Coles, Target, Event Cinemas & Aldi and other relevant retailers as determined by the Promoter.
7. Each entry must be submitted by the time specified in the promotional post to be placed into the prize draw.
8. Any uploaded files must be submitted in accordance with the relevant platform's requirements.
9. Receipts must clearly show the retailer's name, date of purchase (which must be within the Promotion Period), individual item details, and a total purchase amount of \$10.00 or more (inclusive of GST). The Promoter reserves the right to verify the validity of receipts and may contact participating retailers to confirm purchases. Receipts that are unclear, altered, or do not meet the requirements will be deemed invalid.

### LIMITS ON ENTRY

10. Entrants may submit multiple entries, provided each entry is accompanied by a separate qualifying receipt meeting the requirements set out in clause 8a.
11. Where multiple entries are permitted per person, each entry must be **substantially unique** and submitted separately and in accordance with entry requirements.

### DRAW DETAILS

12. The draw will take place at the Participating Centre at 12PM on the day following the closure of competition entries. The Promoter reserves the right to draw reserves in case of an invalid entry or invalid entrant.

#### **WINNER NOTIFICATION**

13. The provisional winner(s) will be notified in writing within two (2) business days of the draw. A provisional winner will only be deemed a winner once verified by the Promoter.

#### **PRIZES**

14. The prize is one (1) Orion Springfield Central Gift Card valued at \$500.00 ("Prize"). The Prize will be awarded to one (1) winner selected at random from all valid entries received during the Promotion Period.
