

## **TERMS AND CONDITIONS FOR MINIS AT THE MOVIES JANUARY 2026 LUCKY DOOR PRIZES**

1. Information on how to enter and prizes form part of these Terms and Conditions. Participation in the Minis at the Movies January 2026 Lucky Door Prizes Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions. All times stipulated in these Terms and Conditions are expressed in AEST Local Time.

### **ELIGIBILITY**

2. Subject to condition 3, this Promotion is only open to Australian residents, accompanied by parents/guardians **aged 18 years or over**.
3. The Promotion is open to **Rhodes Waterside Minis members only**.
4. The following are ineligible: (i) employees of the Promoter, the Mirvac Group or any of the tenants or retailers in any Participating Centre or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, defacto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

  - (a) Be a Minis member at the Participating Centre
  - (b) Have a valid *Minis at the Movies exclusive screening of THE SPONGEBOB MOVIE* ticket
  - (c) Present their *Minis at the Movies exclusive screening of THE SPONGEBOB MOVIE* ticket to the Participating Centre’s Ambassador at Reading Cinemas Rhodes during the Promotion Period.

(d) Collect a prize ticket from the Participating Centre's Ambassador upon presentation of their *Minis at the Movies exclusive screening of THE SPONGEBOB MOVIE* ticket at Reading Cinemas Rhodes during the Promotion Period.

(e) Be in Cinema at Reading Cinemas Rhodes before the prizes are drawn at 10:55am

### **LIMITS ON ENTRIES**

8. Multiple entries are not permitted. One prize ticket is given per valid *Minis at the Movies exclusive screening of THE SPONGEBOB MOVIE* ticket.

### **PRIZE GIVEWAYS**

9. The prizes and values (inclusive of GST) have been assigned as follows:

- a. Prize 1, one (1) x The SpongeBob Movie Flying Dutchmen Toy and one (1) Reading Cinemas Double Pass valued at \$75
- b. Prize 2, one (1) x Reading Cinemas Double Pass valued at \$36

These valuations are for campaign purposes only and reflect the retail price of the items as part of the promotional offer.

10. The total number of prizes to be given away on Wednesday 14 January 2026 is **2**

11. All prizes are to be inspected at the time of collection. The promoter will not be responsible for any damage and the items will not be replaced.

12. The promoter and its representatives accept no responsibility for any variation in the value of the prize.

13. The promoter accepts no liability whatsoever for any loss, damage or injury whatsoever that may arise in any way from the use of the prize or the conduct of the promotion.

### **GENERAL**

14. Incomplete, indecipherable or illegible entries will be deemed invalid.

15. If there is a dispute as to the identity of an entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the entrant.
