- 2. Simply swipe the RHODES WATERSIDE Gift Card, then select 'Savings' on the EFTPOS terminal. The purchase amount must be equal to or less than the balance on the gift card.
- 3. Enter the PIN number on the back of the gift card and press OK.
- 4. The RHODES WATERSIDE Gift Card is valid for a period of 36 months from the issue date, and must be redeemed before the date of expiry.
- 5. Check your RHODES WATERSIDE Gift Card balance and transaction history by visiting www.waivpay.com or calling Customer Care on 1300 764 721.
- 6. Any RHODES WATERSIDE Gift Card that is damaged or faulty at time of issue will be replaced at no extra cost; please call Customer Care on 1300 764 721 for assistance.

Please be aware of the RHODES WATERSIDE Gift Card's remaining balance before making a purchase – if the total cost of items purchased is greater than the balance of the card, you will be required to make up the difference with another payment method.

- The RHODES WATERSIDE Gift Card may be purchased in various denominations from \$5 to \$250. Funds may take up to 48 hours to be activated on your gift card.
- Administration Fees: a \$2.95 fee applies upon the issuance of each RHODES
 WATERSIDE Gift Card using card payments, as well as a postage and handling fee.
- The RHODES WATERSIDE Gift Card is not redeemable for cash and cannot be used for the payment of credit or retailer accounts, nor used at ATMs to withdraw cash.
