## Filming permission for exhibitor stands

Dear exhibitor,

Enforce Tac insists on strict verification of all participants prior to the trade fair. This includes the identification and registration of all visitors, exhibitors and their employees to ensure that all participants meet the high standards of security and professionalism. In addition, we work closely with the relevant authorities and rely on a comprehensive security concept. New, stricter criteria for press and media representatives are now in effect. For this reason, bloggers, influencers and content creators will no longer receive press accreditation. If you wish to use photo or video teams at your stand or have employees from your social media department take pictures, you will need a filming permit, which must be applied for and approved by us in advance.

**Filming is only permitted at your own exhibition stand and must not interfere with the running of the exhibition or other exhibitors and visitors. People may not be photographed without their prior consent. As there is a general ban on filming and photography at Enforce Tac, any violation of this rule will result in immediate expulsion from the premises.**
