GUN SECURITY AND STAND SECURITY MANAGER

Please read the following information on the prevention of theft carefully and then complete the form.

- ▶ Products requiring licences must be secured against theft and unauthorized access at all times of the day and night, expressly also during the trade fair.
- ▶ The presentation must be designed in such a way that they can be viewed by stand personnel at all times.
- ▶ Valuable goods and especially products requiring licenses under German firearms law including arms and items being classified as prohibited or as military must be kept locked away at night.
- ▶ We also recommend a stand guard to ensure the security of your products at night.

Mechanical safety:

- Firearms requiring licences must be mechanically secured with steel cables.
- As a rule, this type of safety device must also be used in display cases or similar (only if display cases have swing bolt locks or an acoustic safety device can an additional safety device be dispensed with).
- ▶ The steel cables themselves must be connected to the respective firearms. No plastic intermediate piece (such as a cable tie) may be used.
- Ammunition must be kept in locked containers (showcases), unless "dummy ammunition" (non-functioning ammunition) is displayed.
- ▶ The permanent presence of stand personnel is no substitute for a mechanical safety device.

Notes:

- ▶ All weapons requiring licences must be appropriately secured by Sunday, 22.02.2026.
- ▶ In the event of inadequate security, the organizer reserves the right to take security measures at the exhibitor's expense.
- ▶ Products requiring licences may only be delivered to the stand from 2 p.m. on Sunday, 22.02.2026. These products must be removed by 8 p.m. on 25.02.2026.

STAND SECURITY MANAGER

Every exhibitor who presents weapons requiring a license on the stand must name a responsible person and a deputy before the trade fair.

The details of the person responsible for the stand and the deputy will be used exclusively for the purpose of contacting the event management and the local authorities.

Naming the stand managers is mandatory for participation in Enforce Tac.

- ▶ The stand manager is responsible for complying with the above-mentioned regulations on gun safety.
- ▶ The stand manager must be present at the stand at all times during set-up, the duration of the trade fair and dismantling if the weapons are not yet or no longer properly secured.
- ▶ In order to be able to contact the stand manager for queries, mobile phone numbers must be entered on the form.
- ▶ The stand manager must be available by telephone for queries at the following times:
 - Last assembly day, 22.02.2026 until 10 p.m.
 - First running day, 23.02.2026 from 7:30 a.m.
- ▶ The deputy stand manager may only take on the above tasks at short notice.
- ▶ The stand manager is responsible for securing the weapons of the direct exhibitor and co-exhibitor.
